## HOUSE BILL No. 1053

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 33-33-73-2 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2017]: Sec. 2. (a) There are  
3 established two (2) courts of record to be known as the Shelby superior  
4 court No. 1 and the Shelby superior court No. 2.  
5 (b) Except as otherwise provided in this chapter, each Shelby  
6 superior court is a standard superior court as described in IC 33-29-1.  
7 (c) **The judges of the Shelby circuit and superior courts may**  
8 **jointly appoint one (1) full-time magistrate under IC 33-23-5 to**  
9 **serve the circuit and superior courts. A magistrate appointed**  
10 **under this section continues in office until jointly removed by the**  
11 **judges of the circuit and superior courts.**  
12 (c) ~~(d)~~ **(d)** Shelby County comprises the judicial district of the courts.
