

HOUSE BILL No. 1063

DIGEST OF HB 1063 (Updated January 15, 2019 3:22 pm - DI 131)

Citations Affected: IC 20-26; IC 20-34; IC 34-30.

Synopsis: School safety equipment. Adds definition of a "bleeding control kit". Provides that, subject to an appropriation by the general assembly, each school corporation and charter school shall develop and implement a Stop the Bleed program (program). Provides that the department of education in collaboration with the department of homeland security shall develop and provide training for the use of bleeding control kits. Provides that, in all matters relating to the program, school corporation or charter school personnel are immune from civil liability for any act done or omitted in the use of a bleeding control kit unless the action constitutes gross negligence or willful or wanton misconduct. Requires a school's safety plan to include the location of bleeding control kits.

Effective: Upon passage.

A BILL FOR AN ACT to amend the Indiana Code concerning education.

Be it enacted by the General Assembly of the State of Indiana:

| 25 | presentation and use of the kits in all drills and emergencies; |
| 26 | (3) provide that all school corporations and charter schools |
| 27 | have a minimum of five (5) individuals in each school building |
| 28 | who obtain appropriate training in the use of the kit, |
| 29 | including: |
| 30 | (A) the proper application of pressure to stop bleeding; |
| 31 | (B) the application of dressings or bandages; |
| 32 | (C) additional pressure techniques to control bleeding; and |
| 33 | (D) the correct application of tourniquets; |
| 34 | (4) require bleeding control kits in school inventories to be |
| 35 | inspected annually to ensure that the materials, supplies, and |
| 36 | equipment contained in the bleeding control kits are not |
| 37 | expired, and that any expired materials, supplies, and |
| 38 | equipment are replaced as necessary; and |
| 39 | (5) require a bleeding control kit to be restocked after each |
| 40 | use and any materials, supplies, and equipment to be replaced |
| 41 | as necessary to ensure that the bleeding control kit contains |

all necessary materials, supplies, and equipment.

SECTION 3. IC 34-30-2-86.1 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE UPON PASSAGE]: Sec. 86.1. IC 20-34-3-24 (Concerning the use of bleeding control kits by school employees). SECTION 4. An emergency is declared for this act.
