Citations Affected: IC 36-5.

Synopsis: Town of Hardinsburg. Legalizes the action of the county commissioners of Washington County dissolving the town of Hardinsburg. Repeals an 1893 act that legalized the incorporation of the town of Hardinsburg.

Effective: Upon passage.

HOUSE BILL No. 1063

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 36-5-1.1-13 IS ADDED TO THE INDIANA CODE
2 AS A **NEW SECTION TO READ AS FOLLOWS [EFFECTIVE**

10 **County, Indiana, dissolving the town of Hardinsburg, Indiana,**
11 **under:**
12 (1) **section 12 of this chapter; and**
13 (2) **each of the ordinances;**
14 **are legalized and ratified, notwithstanding any other provision of**
15 **this chapter, as in effect before January 1, 2023.**
16 (c) **The actions of the elected officers of Washington County**
17 **taken before January 1, 2023, under each of the ordinances, to**

1 **conclude the affairs of the town of Hardinsburg, Indiana, are**
2 **legalized and ratified.**

3 **(d) Acts 1893, c. 42, relating to the town of Hardinsburg is**
4 **repealed.**

5 **SECTION 2. An emergency is declared for this act.**
