A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

32	Sec. 1. The bureau shall design a women veterans license plate
33	that includes the following:
34	(1) A basic design for the plate with consecutive numbers or
35	letters, or both, to properly identify the vehicle.
36	(2) A background design, an emblem, or colors that designate
37	the license plate as a women veterans license plate.
38	(3) An area on the plate for display of an emblem denoting the
39	women veterans license plate.
40	(4) Any other information the bureau considers necessary.
41	Sec. 2. The bureau shall confer with members of women
42	veterans organizations concerning the:

2	(2) emblem used to denote women veterans.
3	Sec. 3. (a) An individual who registers a vehicle under this title
4	may apply for and receive a women veterans license plate for one
5	(1) or more vehicles upon doing the following:
6	(1) Completing an application for a women veterans license
7	plate.
8	(2) Presenting one (1) of the following to the bureau:
9	(A) A DD 214 or DD 215 record.
10	(B) United States military discharge papers.
11	(C) A current armed forces identification card.
12	(3) Paying a fee in the amount of fifteen dollars (\$15).
13	(b) The bureau shall distribute the fee described in subsection
14	(a)(3) to the director of veterans' affairs to fund the Hoosier
15	women veterans program established by IC 10-17-14-6.
