

HOUSE BILL No. 1087

DIGEST OF INTRODUCED BILL

Citations Affected: IC 25-8-15.4.

Synopsis: Tanning facilities. Exempts physicians who, in the practice of medicine, use or prescribe a phototherapy device for a patient from the tanning facility regulatory requirements. (Current law exempts a medical treatment facility that uses ultraviolet radiation in the treatment of disease.) Prohibits an individual less than 18 years of age from using a tanning device in a tanning facility. Requires the operator or owner of a tanning facility to include a statement in the written information required to be signed before an individual may use a tanning device that individuals less than 18 years of age may not use a tanning device. Requires a tanning facility operator to prohibit an individual who is less than 18 years of age from using a tanning device. Requires a tanning facility operator to check a specified government issued photo identification to confirm that an individual is at least 18 years of age before the individual uses a tanning device.

Effective: July 1, 2018.

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 25-8-15.4-1 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2018]: Sec. 1. This chapter does not
3 apply to a ~~medical treatment facility that uses ultraviolet radiation in~~
4 ~~the treatment of disease:~~ **physician who:**

- 5 **(1) is licensed under IC 25-22.5; and**
- 6 **(2) in the practice of medicine, uses or prescribes to be used a**
7 **phototherapy device for a patient.**

8 SECTION 2. IC 25-8-15.4-11 IS AMENDED TO READ AS
9 FOLLOWS [EFFECTIVE JULY 1, 2018]: Sec. 11. Before a person
10 uses a tanning device in a tanning facility, the operator, owner, or
11 employee of the operator or owner of the tanning facility shall require
12 the person to read and sign a written statement approved by the board
13 that contains the following information:

- 14 **(1) A person who is less than eighteen (18) years of age may**
15 **not use a tanning device in a tanning facility.**
- 16 **(2) A person who uses a tanning device in this tanning facility**
17 **must use protective eyewear.**



- 1 ~~(2)~~ **(3)** If the provided eye protection is not worn, use of a tanning
 2 device in this tanning facility may cause damage to the eyes.
 3 ~~(3)~~ **(4)** Overexposure to the ultraviolet radiation produced by a
 4 tanning device in this tanning facility may cause burns.
 5 ~~(4)~~ **(5)** Exposure to the ultraviolet radiation produced by the
 6 tanning devices in this tanning facility may cause premature aging
 7 of the skin and skin cancer.
 8 ~~(5)~~ **(6)** Abnormal skin sensitivity to ultraviolet radiation or
 9 burning may be caused by certain foods, cosmetics, or
 10 medication, including the following:
 11 (A) Tranquilizers.
 12 (B) Diuretics.
 13 (C) Antibiotics.
 14 (D) High blood pressure medication.
 15 (E) Birth control medication.
 16 (F) Other photosensitizing agents as determined under rules
 17 adopted by the board.
 18 ~~(6)~~ **(7)** A person who is taking a prescription drug or an
 19 over-the-counter drug should consult a physician or pharmacist
 20 before using a tanning device.
 21 SECTION 3. IC 25-8-15.4-14 IS AMENDED TO READ AS
 22 FOLLOWS [EFFECTIVE JULY 1, 2018]: Sec. 14. **(a)** The operator of
 23 a tanning facility shall do the following:
 24 **(1) Prohibit an individual who is less than eighteen (18) years**
 25 **of age from using a tanning device in the tanning facility.**
 26 ~~(1)~~ **(2)** Have an employee present in the tanning facility during
 27 business hours who, as determined under rules adopted by the
 28 board, is knowledgeable in the correct operation of the tanning
 29 devices in the tanning facility and is able to assist persons in the
 30 proper use of the tanning devices.
 31 ~~(2)~~ **(3)** Provide each person using a tanning device with properly
 32 sanitized eyewear that protects the eyes from ultraviolet radiation
 33 and allows adequate vision.
 34 ~~(3)~~ **(4)** Provide instructions to each person using a tanning device
 35 on how to maintain proper exposure distance as recommended by
 36 the manufacturer of the tanning device.
 37 ~~(4)~~ **(5)** Limit each person using a tanning device to the maximum
 38 exposure time:
 39 (A) established under rules of the board; or
 40 (B) if the board has not adopted rules concerning exposure
 41 time for the tanning device, recommended by the manufacturer
 42 of the tanning device.



1 ~~(5)~~ **(6)** Not allow the temperature of a tanning facility to exceed
2 one hundred (100) degrees Fahrenheit at any time.

3 ~~(6)~~ **(7)** Provide and maintain:

4 (A) the tanning facility; and

5 (B) tanning devices in the tanning facility;

6 in a manner that meets sanitation and safety rules adopted by the
7 board.

8 **(b) The operator of a tanning facility shall ensure that an**
9 **individual is at least eighteen (18) years of age before the individual**
10 **may use a tanning device at the tanning facility by requiring the**
11 **individual to provide proof of age through at least one (1)**
12 **government issued identification bearing the individual's**
13 **photograph, including a:**

14 **(1) state issued driver's license;**

15 **(2) state issued photographic identification card; or**

16 **(3) passport;**

17 **showing the individual to be at least eighteen (18) years of age.**

18 SECTION 4. IC 25-8-15.4-16, AS AMENDED BY P.L.82-2014,
19 SECTION 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
20 JULY 1, 2018]: Sec. 16. ~~(a)~~ A person who is less than ~~sixteen (16)~~
21 **eighteen (18)** years of age may not use a tanning device in a tanning
22 facility.

23 **(b) A person who is at least sixteen (16) years of age but less than**
24 **eighteen (18) years of age may not use a tanning device in a tanning**
25 **facility unless the parent or guardian of the person has also signed the**
26 **written statement under section 11 of this chapter in the presence of the**
27 **operator of the tanning facility.**
