

HOUSE BILL No. 1100

DIGEST OF INTRODUCED BILL

Citations Affected: IC 10-13-5-6.

Synopsis: Missing persons information distribution. Requires the Indiana clearinghouse for information on missing children and missing endangered adults to publish the photographs of missing children and missing endangered adults on the clearinghouse's Internet web site or in hard copy.

Effective: July 1, 2016.

HOUSE BILL No. 1100

A BILL FOR AN ACT to amend the Indiana Code concerning public safety.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 10-13-5-6, AS AMENDED BY P.L.43-2009,
2 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2016]: Sec. 6. (a) The superintendent shall designate staff
4 responsible for the operation of the clearinghouse.
5 (b) The staff's duties include the following:
6 (1) Creation and operation of an intrastate network of
7 communication designed for the speedy collection and processing
8 of information concerning missing children and missing
9 endangered adults.
10 (2) Creation and operation of a central data storage, retrieval, and
11 information distribution system designed for the exchange of
12 information on missing children and missing endangered adults
13 within and outside Indiana. The system must be capable of
14 interacting with:
15 (A) the Indiana data and communication system under
16 IC 10-13-3-35; and
17 (B) the National Crime Information Center.



- 1 (3) Development of appropriate forms for the reporting of missing
2 children and missing endangered adults that may be used by law
3 enforcement agencies and private citizens to provide useful
4 information about a missing child or a missing endangered adult
5 to the clearinghouse.
- 6 (4) Cooperation with the following agencies concerning the
7 location of missing children and missing endangered adults:
- 8 (A) State and local public and private nonprofit agencies
9 involved with the location and recovery of missing persons.
- 10 (B) Agencies of the federal government.
- 11 (C) State and local law enforcement agencies within and
12 outside Indiana.
- 13 (5) Coordinating efforts to locate missing children and missing
14 endangered adults with the agencies listed in subdivision (4).
- 15 (6) Operation of the toll free telephone line created under section
16 7(a) of this chapter.
- 17 (7) Publishing and updating, on a quarterly basis, a directory of
18 missing children and missing endangered adults.
- 19 (8) Compiling statistics on missing children and missing
20 endangered adult cases handled by the clearinghouse, including
21 the number of cases resolved each year.
- 22 **(9) Publishing photographs of missing children and missing**
23 **endangered adults on the clearinghouse's Internet web site or**
24 **in hard copy.**
