

# HOUSE BILL No. 1118

## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 25-1-5.5-2; IC 25-8-4-1.5.

**Synopsis:** Eyelash extension stylists. Adds eyelash extension stylists to the electronic registry of professions. Provides that an individual is not required to receive a license from the state board of cosmetology and barber examiners to apply, maintain, and remove eyelash extensions if the individual: (1) meets certain training and supervised practice requirements; (2) is certified as an eyelash extension stylist by a certifying organization; (3) displays the certificate when providing eyelash extension services; and (4) is registered under the electronic registry of professions.

**Effective:** July 1, 2018.

# HOUSE BILL No. 1118

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 25-1-5.5-2, AS AMENDED BY P.L.240-2015,  
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2018]: Sec. 2. As used in the chapter:  
4 (1) "Applicant" refers to a person who applies for a registration in  
5 the electronic registry of professions.  
6 (2) "Executive director" refers to the executive director of the  
7 licensing agency appointed under IC 25-1-5-5.  
8 (3) "Licensing agency" means the Indiana professional licensing  
9 agency created by IC 25-1-5-3.  
10 (4) "Registrant" means an individual who is registered in the  
11 electronic registry of professions as **any of the following**:  
12 (A) An individual state registered under IC 25-1-18. ~~or~~  
13 (B) An interior designer under IC 25-20.7.  
14 (C) **An eyelash extension stylist under IC 25-8-4-1.5.**  
15 (5) "Registry" refers to the electronic registry of professions  
16 established by section 1 of this chapter.  
17 SECTION 2. IC 25-8-4-1.5 IS ADDED TO THE INDIANA CODE



1 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
2 1, 2018]: **Sec. 1.5. An individual is not required to obtain a license  
3 under this article to apply, preserve, and remove eyelash extensions  
4 if the individual meets the following requirements:**

- 5 **(1) The individual has received not less than the following:**  
6 **(A) Sixteen (16) hours of training and instruction that**  
7 **includes the following topics:**  
8 **(i) Safety and sanitation.**  
9 **(ii) Application and removal of eyelash extensions.**  
10 **(iii) Separation of eyelashes.**  
11 **(iv) The proper application of glue and coloring to**  
12 **eyelashes.**  
13 **(B) Sixteen (16) hours of supervised practice of applying,**  
14 **maintaining, and removing eyelash extensions on volunteer**  
15 **clients.**  
16 **(2) The individual is certified as an eyelash extension stylist by**  
17 **a certifying organization that:**  
18 **(A) has the ability to certify, decertify, and monitor the**  
19 **individual in the profession of applying, maintaining, and**  
20 **removing eyelash extensions;**  
21 **(B) has the ability to investigate consumer complaints**  
22 **against the individual; and**  
23 **(C) requires the individual to pass a written and practical**  
24 **examination that is administered by the certifying**  
25 **organization or an organization that is approved by the**  
26 **certifying organization.**  
27 **(3) The individual prominently displays the individual's active**  
28 **certificate received from the certifying organization under**  
29 **subdivision (2) that is clearly visible to a customer receiving**  
30 **eyelash extension services.**  
31 **(4) The individual is registered under IC 25-1-5.5 as a eyelash**  
32 **extension stylist.**
