DIGEST OF INTRODUCED BILL

Citations Affected: IC 34-30-26-5.

Synopsis: Lien on vacant or abandoned real property. Provides that a tax sale certificate holder or an applicant for a tax deed who enters the premises of certain vacant or abandoned real property to perform the action of: (1) securing the real property; (2) removing trash or debris from the grounds of the real property; (3) landscaping, maintaining, or mowing the grounds of the real property; or (4) removing or painting over graffiti on the real property; has a lien on the real property equal to the amount of the reasonable value of labor performed and materials used to perform the action.

Effective: July 1, 2016.

A BILL FOR AN ACT to amend the Indiana Code concerning civil law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

8	visually inspect the real property to determine whether the real
