

HOUSE BILL No. 1144

DIGEST OF HB 1144 (Updated February 6, 2025 12:07 pm - DI 125)

Citations Affected: IC 33-33.

Synopsis: Courts and court officers. Adds two superior courts to Hamilton County. Provides that the first judges of Hamilton superior courts No. 8 and No. 9 shall: (1) be elected at the November 2026 general election; (2) take office January 1, 2027; and (3) serve a term of six years. Allows the judges of the Hamilton circuit and superior courts to jointly appoint two additional magistrates to serve the Hamilton County courts. Allows the judges of the Elkhart circuit and superior courts to appoint five full-time magistrates. (Current law allows for the appointment of two magistrates.) Allows the judges of the Vigo circuit and superior courts to jointly appoint one magistrate to serve the Vigo County courts.

Effective: July 1, 2025.

COMMITTEE REPORT

Mr. Speaker: Your Committee on Ways and Means, to which was referred House Bill 1144, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill be amended as follows:

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 33-33-20-2, AS AMENDED BY P.L.1-2006, SECTION 503, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2025]: Sec. 2. (a) The judges of the Elkhart circuit and superior courts may jointly appoint two five (5) full-time magistrates under IC 33-23-5 to serve the circuit and superior courts.

(b) A magistrate continues in office until removed by the judges of the circuit and superior courts.".

Page 2, after line 19, begin a new paragraph and insert:

"SECTION 5. IC 33-33-84-22 IS ADDED TO THE INDIANA CODE AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2025]: Sec. 22. (a) The judges of the Vigo circuit and superior courts may jointly appoint one (1) full-time magistrate under IC 33-23-5 to serve the circuit and superior courts.

(b) The magistrate continues in office until removed by the judges of the Vigo circuit and superior courts.".

Renumber all SECTIONS consecutively.
