## HOUSE BILL No. 1149

---

DIGEST OF HB 1149 (Updated January 23, 2025 8:50 am - DI 140)

**Citations Affected:** IC 15-11.

**Synopsis:** Agricultural online portal. Requires the Indiana state department of agriculture (department) to establish and maintain an online portal on its website for the purposes of: (1) assisting users in the successful navigation of agricultural or related topics among various federal and state agencies; (2) providing a single source for users to access agricultural or related funding opportunities; (3) providing a searchable data base of available federal and state grants with information on eligibility and deadline criteria; and (4) providing regular updates to reflect changes in federal and state funding opportunities. Provides that the online portal shall include links to various federal and state websites. Requires that the online portal provide a series of regulatory checklists to assist users that are considering diversifying into new markets in the navigation of agricultural and related regulations and the avoidance of punitive enforcement actions before they arise. Requires that the online portal provide a one stop venue that will help connect users with responsive data visualization tools and technical assistance programming. Requires that the online portal include a link to provide users with ongoing updates on the status of certain lost farmland. Requires an updated report on certain lost farmland to be uploaded to the online portal every five years. Requires that the online portal include formal venues: (1) to collect comments from the public regarding federal regulations impacting Indiana's rural economy with the goal of assisting the state in providing vigorous advocacy on behalf of the public; and (2) where users may provide to the department reviews and feedback regarding the usefulness of the online portal.

## HOUSE BILL No. 1149

A BILL FOR AN ACT to amend the Indiana Code concerning agriculture and animals.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 15-11-2-9 IS ADDED TO THE INDIANA CODE  
2 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2025]: **Sec. 9. (a) As used in this section, "user" includes:**  
4 (1) a rural community;  
5 (2) a farmer;  
6 (3) an agribusiness; or  
7 (4) any other individual or entity using the online portal  
8 established under this section for the purposes described in  
9 subsection (d).  
10 (b) The department shall establish an online portal on the  
11 department's website.  
12 (c) The department shall administer the online portal.  
13 (d) The purposes of the online portal shall be to:  
14 (1) assist users in the successful navigation of agricultural or  
15 related topics among various federal and state agencies;  
16 (2) provide a single source for users to access agricultural or  
17 related federal and state funding opportunities;

- 1           (3) provide a searchable data base of available federal and  
2 state grants with information on eligibility and deadline  
3 criteria; and  
4           (4) provide regular updates to reflect changes in federal and  
5 state funding opportunities.  
6           (e) The online portal shall include links that will facilitate the  
7 navigation of the websites of various federal and state agencies,  
8 including the following:  
9           (1) The United States Department of Agriculture.  
10           (2) The United States Department of Agriculture's Natural  
11 Resources Conservation Service.  
12           (3) The United States Environmental Protection Agency.  
13           (4) The department of environmental management established  
14 by IC 13-13-1-1.  
15           (5) The Indiana state board of animal health established by  
16 IC 15-17-3-1.  
17           (6) The office of state chemist (and by virtue of office, the  
18 state seed commissioner under IC 15-15-1-26) established by  
19 IC 15-16-2-24.  
20           (7) The office of community and rural affairs established by  
21 IC 4-4-9.7-4.  
22           (8) Any other federal or state agency, the interaction with  
23 which would be helpful to users.  
24           (f) To accomplish the purposes described in subsection (d), the  
25 online portal shall do the following:  
26           (1) Provide a series of regulatory checklists for users that are  
27 considering diversifying into new markets to assist users in:  
28           (A) the navigation of agricultural and related regulations;  
29           and  
30           (B) the avoidance of punitive enforcement actions before  
31 they arise.  
32           (2) Assist users in collaborating with:  
33           (A) the Purdue University cooperative extension service;  
34           (B) the state climate office hosted by Purdue University;  
35           and  
36           (C) the United States Department of Agriculture;  
37 to create a one stop venue that will help connect users with  
38 responsive data visualization tools and technical assistance  
39 programming.  
40           (3) Provide a one stop venue where users may gather  
41 information regarding, and apply for, available federal and  
42 state agricultural and related funding opportunities.



- 1           **(4) Include a link to provide users with ongoing updates on the**  
 2           **status of land that was identified as lost farmland included in**  
 3           **the department's inventory of lost farmland, and as reported**  
 4           **by the department, under IC 15-11-9-1.1 (before its**  
 5           **expiration) or IC 15-11-9-1.3.**
- 6           **(5) Include a formal venue to collect comments from the**  
 7           **public regarding federal regulations that impact Indiana's**  
 8           **rural economy with the goal of assisting the state in providing**  
 9           **vigorous advocacy on behalf of the public.**
- 10           **(6) Include a formal venue where users may provide to the**  
 11           **department reviews and feedback regarding the usefulness of**  
 12           **the online portal.**
- 13           SECTION 2. IC 15-11-9-1.3 IS ADDED TO THE INDIANA CODE  
 14           AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
 15           1, 2025]: Sec. 1.3. (a) As used in this section, "farmland" refers to  
 16           property described in IC 14-22-11-1(a)(2).
- 17           (b) Beginning in 2029, and every fifth year thereafter, before  
 18           November 1, after the most current release of the United States  
 19           Department of Agriculture National Agricultural Statistics  
 20           Service's Census of Agriculture, the department shall:
- 21           (1) conduct an inventory of all farmland lost in Indiana  
 22           during the five (5) years following the department's prior  
 23           report; and
- 24           (2) identify the primary cause of the reduction of farmland  
 25           under subdivision (1).
- 26           (c) After conducting each inventory under subsection (b), the  
 27           department shall issue a report to the legislative council containing  
 28           the department's findings and recommendations, including any  
 29           recommended legislation, in an electronic format under IC 5-14-6  
 30           before November 1 of the year in which the inventory is conducted.  
 31           Within thirty (30) days after issuing the report required under this  
 32           subsection to the legislative council, the department shall upload  
 33           the report to the online portal.
