DIGEST OF INTRODUCED BILL

Citations Affected: IC 14-22-11-18.1.

Synopsis: Hunting season for disabled veterans. Provides that the director of the department of natural resources may designate four days a year as free hunting days for critically disabled veterans to take place on the same dates as free hunting days for youth. Defines "critically disabled veteran".

HOUSE BILL No. 1150

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 14-22-11-18.1 IS ADDED TO THE INDIANA
2	CODE AS A NEW SECTION TO READ AS FOLLOWS
3	[EFFECTIVE JULY 1, 2023]: Sec. 18.1. (a) As used in this section,
4	"critically disabled veteran" means an individual who:
5	(1) served in:
6	(A) the armed forces of the United States or their reserves;
7	(B) the Indiana Army National Guard; or
8	(C) the Indiana Air National Guard;
9	(2) was released from active duty under conditions other than
10	dishonorable;
11	(3) has suffered from:
12	(A) the loss of a limb or limbs;
13	(B) the loss of one (1) or both hands;
14	(C) the loss of one (1) or both feet; or
15	(D) a permanent physical disability that requires the use of
16	a wheelchair, a walker, braces, or crutches;
17	as a result of the service described in subdivision (1); and



1	(4) has a record of the impairment described in subdivision (3)
2	as evidenced by:
3	(A) records of the United States Department of Veterans
4	Affairs; or
5	(B) disability retirement benefits awarded to the individual
6	under laws administered by the United States Department
7	of Defense.
8	(b) The director may designate not more than four (4) days each
9	year as free hunting days for critically disabled veterans to take
10	place on the same dates as free hunting days for youth under
11	section 18 of this chapter.
12	(c) During a free hunting day for critically disabled veterans
13	designated under subsection (b), a resident who is a critically
14	disabled veteran may:
15	(1) hunt using hunting methods that are designated by the
16	director and that are legal for that hunting season; and
17	(2) exercise the same privileges that a resident is entitled to
18	under IC 14-22-12-1(a).
19	A critically disabled veteran is not required to pay a fee or possess
20	a hunting license.
21	(d) A critically disabled veteran who hunts during a free
22	hunting day under this section must:
23	(1) comply with the conditions and rules adopted by the
24	director; and
25	(2) be accompanied by an individual who is at least eighteen
26	(18) years of age.
27	(e) The individual who accompanies a critically disabled veteran
28	under subsection (d)(2):
29	(1) is not required to:
30	(A) hold a valid hunting license under IC 14-22-12; or
31	(B) have a hunting license under this chapter;
32	(2) must be in close enough proximity to:
33	(A) monitor the critically disabled veteran's activities; and
34	(B) communicate with the critically disabled veteran at all
35	times; and
36	(3) may assist the critically disabled veteran, including calling
37	but may not carry a firearm or how and arrow
