### HOUSE BILL No. 1150

DIGEST OF HB 1150 (Updated February 8, 2023 11:45 am - DI 148)

Citations Affected: IC 14-8; IC 14-22.

**Synopsis:** Hunting season for disabled veterans. Provides that the director of the department of natural resources shall designate four days a year as free hunting days for critically disabled veterans and youth hunters. Defines "critically disabled veteran".

Effective: July 1, 2023.

### HOUSE BILL No. 1150

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

#### Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 14-8-2-62.3 IS ADDED TO THE INDIANA CODE
2	AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3	1, 2023]: Sec. 62.3. "Critically disabled veteran", for purposes of
4	IC 14-22-11-18, means an individual who:

7	(B) the Indiana Army National Guard; or
8	(C) the Indiana Air National Guard;
9	(2) was released from active duty under conditions other than

13	(B) the loss of one (1) or both hands;
14	(C) the loss of one (1) or both feet; or
15	(D) a permanent physical disability that requires the use of
16	a wheelchair, a walker, braces, or crutches;
17	as a result of the individual's service described in subdivision
