

## **ENGROSSED HOUSE BILL No. 1182**

DIGEST OF HB 1182 (Updated March 13, 2019 12:45 pm - DI 132)

Citations Affected: IC 22-3; IC 36-8.

Worker's compensation. Provides that, for worker's compensation purposes, an employee who leaves work to serve as a volunteer firefighter or member of a volunteer emergency medical services association (volunteer member) is considered an employee of the firefighting unit while in the performance of duties as a volunteer firefighter or volunteer member. Increases the maximum amount of burial expenses that an employer must pay under the worker's compensation act for the burial expenses of a covered employee who dies from an injury by an accident arising out of the employee's employment from \$7,500 to \$10,000. Increases the maximum amount of burial expenses that an employer must pay under the worker's of burial expenses that an employer must pay under the worker's occupational diseases compensation act for the burial expenses of an employee who dies from an occupational disease arising out of the employee's employment from \$7,500 to \$10,000.

Effective: July 1, 2019.

## ENGROSSED HOUSE BILL No. 1182

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

*Be it enacted by the General Assembly of the State of Indiana:* 

SECTION 1. IC 22-3-3-21, AS AMENDED BY P.L.201-2005, SECTION 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2019]: Sec. 21. In cases of the death of an employee from an injury by an accident arising out of and in the course of the employee's employment under circumstances that the employee would have been entitled to compensation if death had not resulted, the employer shall pay the burial expenses of such employee, not exceeding seven ten thousand five hundred dollars (\$7,500). (\$10,000).

SECTION 2. IC 22-3-7-15, AS AMENDED BY P.L.201-2005, SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2019]: Sec. 15. In cases of the death of an employee from an occupational disease arising out of and in the course of the employee's employment under circumstances that the employee would have been entitled to compensation if death had not resulted, the employer shall pay the burial expenses of such employee, not exceeding seven ten thousand five hundred dollars (\$7,500). (\$10,000).

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 22-3-3-21, AS AMENDED BY P.L.201-2005, SECTION 4, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2019]: Sec. 21. In cases of the death of an employee from an injury by an accident arising out of and in the course of the employee's employment under circumstances that the employee would have been entitled to compensation if death had not resulted, the employer shall pay the burial expenses of such employee, not exceeding seven twelve thousand five hundred dollars (\$7,500). (\$12,500).

(\$12,500)."
