19	(7) Red 3 (CAS 16423-68-0).
20	(8) Red 40 (CAS 25956-17-6).
21	(9) Yellow 5 (CAS 1934-21-0).

23	Sec. 4. A person may not do the following in Indiana:
24	(1) Sell food containing a prohibited food additive.
25	(2) Store food containing a prohibited food additive.
26	(3) Distribute food containing a prohibited food additive.
27	(4) Use a prohibited food additive in the preparation of food.
28	(5) Manufacture a prohibited food additive.
29	Sec. 5. The state department may adopt rules under IC 4-22-2
