## HOUSE BILL No. 1248

---

DIGEST OF HB 1248 (Updated January 26, 2022 3:50 pm - DI 139)

**Citations Affected:** IC 14-8; IC 14-22.

**Synopsis:** Direct contact with specified animals. Prohibits a person that owns or possesses a specified animal from allowing a member of the public to come into direct contact, or enter into a proximity that allows for or permits direct contact, with the specified animal. Provides that a violation of the law is a Class B infraction. Excludes from the substance of the bill physical contact or proximity between certain individuals and a specified animal. Defines the terms "direct contact", "proximity", "specified animal", and "trained".

**Effective:** July 1, 2022.

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 14-8-2-70.8 IS ADDED TO THE INDIANA CODE  
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2022]: **Sec. 70.8. "Direct contact", for purposes of IC 14-22-26.5,**  
4 **has the meaning set forth in IC 14-22-26.5-2.**
- 5 SECTION 2. IC 14-8-2-221.5 IS ADDED TO THE INDIANA  
6 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
7 [EFFECTIVE JULY 1, 2022]: **Sec. 221.5. "Proximity", for purposes**  
8 **of IC 14-22-26.5, has the meaning set forth in IC 14-22-26.5-3.**
- 9 SECTION 3. IC 14-8-2-262.5 IS ADDED TO THE INDIANA  
10 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
11 [EFFECTIVE JULY 1, 2022]: **Sec. 262.5. "Specified animal", for**  
12 **purposes of IC 14-22-26.5, has the meaning set forth in**  
13 **IC 14-22-26.5-4.**
- 14 SECTION 4. IC 14-8-2-282.5 IS ADDED TO THE INDIANA  
15 CODE AS A **NEW** SECTION TO READ AS FOLLOWS  
16 [EFFECTIVE JULY 1, 2022]: **Sec. 282.5. "Trained", for purposes of**  
17 **IC 14-22-26.5, has the meaning set forth in IC 14-22-26.5-5.**

1 SECTION 5. IC 14-22-26.5 IS ADDED TO THE INDIANA CODE  
 2 AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE  
 3 JULY 1, 2022]:

4 **Chapter 26.5. Specified Animals**

5 **Sec. 1. This chapter does not apply to physical contact or**  
 6 **proximity between a specified animal and any of the following:**

7 (1) The owner of the facility in which the specified animal is  
 8 kept.

9 (2) A trained employee of the facility's owner who is  
 10 conducting the trained employee's duties, as determined by  
 11 the facility's owner, for the specified animal.

12 (3) A contractor, intern, service provider, or another person  
 13 who:

14 (A) is accompanied by the facility's owner; and

15 (B) is performing duties requiring the presence of the  
 16 specified animal;

17 under a contract or other engagement with the facility's  
 18 owner.

19 (4) A licensed veterinarian.

20 (5) A veterinary intern or specialist accompanying a licensed  
 21 veterinarian.

22 (6) A registered veterinary technician under the direct or  
 23 indirect supervision of a licensed veterinarian.

24 (7) A veterinary student under the direct supervision of a  
 25 licensed veterinarian.

26 **Sec. 2. (a) As used in this chapter, "direct contact" means**  
 27 **physical contact between the public and a specified animal.**

28 (b) The term includes the taking of a photograph of a specified  
 29 animal except where there is located between the public and the  
 30 specified animal a permanent physical barrier designed to prevent  
 31 physical contact between the public and the specified animal.

32 **Sec. 3. As used in this chapter, "proximity" means a distance**  
 33 **created by a visual or physical barrier, including a barrier fence,**  
 34 **safety line, or other means to signify a restricted area, that is**  
 35 **designed to prevent a member of the public from touching a**  
 36 **primary, permeable barrier that contains a specified animal.**

37 **Sec. 4. As used in this chapter, "specified animal" means a live**  
 38 **animal that is any of the following:**

39 (1) An animal from the following species of Felidae:

40 (A) Lions (*Panthera leo*).

41 (B) Tigers (*Panthera tigris*).

42 (C) Leopards (*Panthera pardus*).



- 1                   (D) Snow leopards (*Panthera uncia*).
- 2                   (E) Jaguars (*Panthera onca*).
- 3                   (F) Mountain lions (*Puma concolor*).
- 4                   (G) Any hybrid of a species listed in clauses (A) through
- 5                   (F).
- 6                   (2) A bear (*Ursidae*).
- 7                   Sec. 5. As used in this chapter, "trained" means having
- 8                   participated in specific instruction with a specified animal.
- 9                   Sec. 6. A person that owns or possesses a specified animal may
- 10                  not allow a member of the public to:
- 11                   (1) come into direct contact with; or
- 12                   (2) enter into a proximity that allows for or permits direct
- 13                   contact with;
- 14                  the specified animal, regardless of the age of the specified animal.
- 15                  Sec. 7. The department may adopt rules under IC 4-22-2 to
- 16                  implement this chapter.
- 17                  Sec. 8. A person that violates this chapter commits a Class B
- 18                  infraction.
