## **ENGROSSED** HOUSE BILL No. 1266

DIGEST OF HB 1266 (Updated March 24, 2021 4:00 pm - DI 110)

Citations Affected: IC 20-19; noncode.

Synopsis: Education building and transportation authorities. Requires the department of education (department) to issue a request for information concerning the possible establishment of educational building authorities and educational transportation authorities that would operate kindergarten through grade 12 school buildings, or other educational experience centers, and kindergarten through grade 12 transportation, respectively. Provides that the deadline for submission of responses to the request for information may not be later than September 1, 2021. Requires the department to prepare and submit, not later than October 1, 2021, a report that includes the information regarding the responses to the request for information and any recommendations by the department. Urges the legislative council to assign to an appropriate study committee for the 2021 interim the task of raviewing the responses to the request for the 2021 interim the task of reviewing the report submitted by the department.

Effective: Upon passage.

## ENGROSSED HOUSE BILL No. 1266

A BILL FOR AN ACT to amend the Indiana Code concerning local government.

Be it enacted by the General Assembly of the State of Indiana:

Page 1, line 3, after "order" insert "to explore potential opportunities".

Page 1, line 4, delete "school services and increase dollars to



teachers," and insert "**noninstructional school services**, allow for any resulting cost savings to transfer from the operations fund to the education fund, and find ways to increase dollars to the classroom,".

Page 1, line 5, delete "before July 1, 2021,".

Page 1, line 5, delete "shall" and insert "shall, not later than June 1, 2021,".

Page 1, delete line 17, begin a new line block indented and insert:

"(1) The governance structure of the entities managing the operations of the:

(A) school buildings; and

(B) transportation.

(2) The funding streams necessary to cover the cost of operating the:

(A) school buildings; and

(B) transportation.

(3) The strategies for addressing existing debt related to the:

(A) school buildings; and

**(B)** transportation.

(4) The optimal geographic groupings for the operation of the:

(A) school buildings; and

(B) transportation.

(5) The strategies that could limit the impact of any changes affecting current employees.".

Page 2, delete lines 1 through 9.

Page 2, line 12, delete "November 30," and insert "September 1,".

Page 2, between lines 12 and 13, begin a new paragraph and insert:

"(d) Subject to IC 5-23-4.5-3, the department shall prepare a report that includes:

(1) information regarding the responses to the request for information under this section, including a copy of a response to the request for information if the person who submitted the response waived confidentiality in writing; (2) any recommendations by the department regarding the request for information or the responses to the request for information; and

(3) any other information that the department determines is relevant to the request for information.

The department shall, not later than October 1, 2021, submit the report to the legislative council in an electronic format under IC 5-14-6.

(e) This section expires July 1, 2022.



SECTION 2. [EFFECTIVE UPON PASSAGE] (a) The legislative council is urged to assign to an appropriate study committee for the 2021 interim the task of reviewing the report submitted by the department under IC 20-19-3-23.2(d), as added by this act. If the study committee makes recommendations regarding the report submitted by the department, the study committee shall consider the potential impact on students, parents, school employees, and communities.

**(b)** This SECTION expires January 1, 2022.". Renumber all SECTIONS consecutively.
