HOUSE BILL No. 1274

A BILL FOR AN ACT to amend the Indiana Code concerning alcohol and tobacco.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 7.1-3-27-8, AS AMENDED BY P.L.159-2014,
2 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2016]: Sec. 8. (a) The holder of an artisan distiller's permit
4 may do only the following:
5 (1) Manufacture liquor, including blending liquor purchased from
6 another manufacturer with liquor the artisan distiller
7 manufactures under section 11 of this chapter.
8 (2) Bottle liquor manufactured by the artisan distiller.
9 (3) Store liquor manufactured by the artisan distiller.
10 (4) Transport, sell, and deliver liquor manufactured by the artisan
11 distiller to:
12 (A) places outside Indiana; or
13 (B) the holder of a liquor wholesaler's permit under IC 7.1-3-8.
14 (5) Sell liquor manufactured by the artisan distiller to consumers
15 by the drink, bottle, or case from the premises of the distillery
16 where the liquor was manufactured.
17 (6) Serve complimentary samples of the liquor manufactured by

1 the artisan distiller to consumers on the premises of the distillery
2 where the liquor was manufactured.

3 **(7) Sell liquor as authorized by this section for carryout on**
4 **Sunday.**

5 (b) The holder of an artisan distiller's permit who provides samples
6 or sells liquor by the glass must furnish the minimum food
7 requirements prescribed by the commission.

8 (c) An artisan distiller who knowingly or intentionally violates this
9 section commits a Class B misdemeanor.
