HOUSE BILL No. 1274

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 9-18.5-36 IS ADDED TO THE INDIANA CODE
2	AS A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE
3	JANUARY 1, 2025]:
4	Chapter 36. Semiquincentennial License Plate
5	Sec. 1. The bureau shall design and issue a semiquincentennial
6	license plate.
7	Sec. 2. A semiquincentennial license plate shall be available for
8	issuance through December 31, 2026.
9	Sec. 3. A person that is eligible to register a vehicle under this
10	title is eligible to receive a semiquincentennial license plate under
11	this chapter upon doing the following:
12	(1) Completing an application for a semiquincentennial
13	license plate.
14	(2) Paying the fee under section 5 of this chapter.
15	Sec. 4. A semiquincentennial license plate must include the
16	following:
17	(1) A basic design for the plate, with consecutive numbers or

1 letters, or both, to properly identify the vehicle. 2 (2) A background design, an emblem, or colors that designate 3 the license plate as a semiquincentennial license plate. 4 (3) Any other information the bureau considers necessary. 5 Sec. 5. (a) The fee for a semiquincentennial plate is twenty-five 6 dollars (\$25). 7 (b) The fee described in subsection (a) shall be collected by the 8 bureau and deposited in the semiquincentennial trust fund 9 established by section 6 of this chapter. 10 Sec. 6. (a) The semiquincentennial trust fund is established. 11 (b) The treasurer of state shall invest the money in the 12 semiquincentennial trust fund not currently needed to meet the 13 obligations of the semiquincentennial trust fund in the same 14 manner as other public funds are invested. Interest that accrues 15 from these investments shall be deposited in the 16 semiquincentennial trust fund. Money in the semiquincentennial 17 trust fund is continuously appropriated for the purposes of this 18 section. 19 (c) The bureau shall administer the semiquincentennial trust fund. Expenses of administering the semiquincentennial trust fund 20 21 shall be paid from money in the trust fund. 22 (d) The bureau shall distribute at least one (1) time each month 23 the money from the semiquincentennial trust fund to the 24 semiquincentennial commission established under IC 4-23-34. 25 (e) Money in the semiquincentennial trust fund at the end of a 26 state fiscal year does not revert to the state general fund.
