

HOUSE BILL No. 1275

DIGEST OF INTRODUCED BILL

Citations Affected: IC 4-13.1-2; IC 5-22-5-10.

Synopsis: State agency information technology. Requires the office of technology (office) to establish integration criteria for acquisition by state agencies of new or revised information technology. Requires the office to review and approve or disapprove state agency budget requests and proposed contracts based on the criteria. Requires the office to work with state agencies to ensure that new or revised information technology meets the integration criteria.

Effective: July 1, 2016.

HOUSE BILL No. 1275

A BILL FOR AN ACT to amend the Indiana Code concerning state and local administration.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 4-13.1-2-2, AS AMENDED BY P.L.2-2007,
2 SECTION 39, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2016]: Sec. 2. (a) The office shall do the following:
4 (1) Develop and maintain overall strategy and architecture for the
5 use of information technology in state government.
6 (2) Review state agency budget requests and proposed contracts
7 relating to information technology ~~at the request of the budget~~
8 ~~agency. and approve or disapprove the requests or proposed~~
9 **contracts based on the office's determination of whether the**
10 **requests and proposed contracts conform to the office's**
11 **integration criteria established under subdivision (3).**
12 (3) Coordinate state information technology master planning and
13 **establish integration criteria for any new or revised**
14 **information technology acquired by a state agency to:**
15 (A) **be integrated with the information technology of other**
16 **state agencies; and**
17 (B) **allow information that is:**



- 1 **(i) stored by the state agency on the new or revised**
 2 **information technology; and**
 3 **(ii) needed by another state agency;**
 4 **to be accessible to the other state agency.**
 5 (4) Maintain an inventory of significant information technology
 6 resources and expenditures.
 7 (5) Manage a computer gateway to carry out or facilitate public,
 8 educational, and governmental functions.
 9 (6) Provide technical staff support services for state agencies.
 10 (7) Provide services that may be requested by the following:
 11 (A) The judicial department of state government.
 12 (B) The legislative department of state government.
 13 (C) A state educational institution.
 14 (D) A political subdivision (as defined in IC 36-1-2-13).
 15 (E) A body corporate and politic created by statute.
 16 (F) An entity created by the state.
 17 (8) Monitor trends and advances in information technology.
 18 (9) Review projects, architecture, security, staffing, and
 19 expenditures.
 20 (10) Develop and maintain policies, procedures, and guidelines
 21 for the effective and secure use of information technology in state
 22 government.
 23 (11) Advise the state personnel department on guidelines for
 24 information technology staff for state agencies.
 25 (12) Conduct periodic management reviews of information
 26 technology activities within state agencies:
 27 (A) upon request; or
 28 (B) **to ensure that any new or revised information**
 29 **technology is:**
 30 **(i) integrated with the information technology of; and**
 31 **(ii) used in a manner that provides accessibility to;**
 32 **other state agencies that need the same information.**
 33 (13) Seek funding for technology services from the following:
 34 (A) Grants.
 35 (B) Federal sources.
 36 (C) Gifts, donations, and bequests.
 37 (D) Partnerships with other governmental entities or the
 38 private sector.
 39 (E) Appropriations.
 40 (F) Any other source of funds.
 41 (14) Perform other information technology related functions and
 42 duties as directed by the governor.



1 (b) The office may adopt rules under IC 4-22-2 that are necessary
2 or appropriate in carrying out its powers and duties.

3 SECTION 2. IC 4-13.1-2-5, AS ADDED BY P.L.177-2005,
4 SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
5 JULY 1, 2016]: Sec. 5. State agencies shall use information technology
6 services provided by the office ~~when directed by the governor~~. **as**
7 **described in this chapter.**

8 SECTION 3. IC 4-13.1-2-6, AS ADDED BY P.L.177-2005,
9 SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
10 JULY 1, 2016]: Sec. 6. (a) The office may request the director of
11 information technology services or another knowledgeable individual
12 employed by a state agency to advise and assist the office in carrying
13 out the functions of the office.

14 (b) State agencies may consult with the office concerning hiring
15 information technology directors and staff.

16 (c) At the request of the office, a state agency shall submit an
17 inventory of all significant information technology hardware, software,
18 personnel, and information technology contracts.

19 (d) **A state agency and the office shall collaborate concerning**
20 **any proposed new or revised information technology hardware,**
21 **software, personnel, or information technology contract to ensure**
22 **that the integration criteria established under section 2 of this**
23 **chapter are met by the proposal.**

24 SECTION 4. IC 5-22-5-10 IS ADDED TO THE INDIANA CODE
25 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
26 1, 2016]: Sec. 10. **When purchasing information technology (as**
27 **defined in IC 4-13.1-1-2), a state agency shall consult with and**
28 **obtain the approval of the office of technology established by**
29 **IC 4-13.1-2-1 to ensure that the information technology meets the**
30 **integration criteria established under IC 4-13.1-2-2 for new or**
31 **revised information technology purchased by a state agency.**
