

ENGROSSED HOUSE BILL No. 1277

DIGEST OF HB 1277 (Updated February 26, 2018 11:40 am - DI 84)

Citations Affected: IC 25-34.1.

Synopsis: Appraisal contracts. Provides that before an appraisal management company may engage a real estate appraiser to perform the appraisal, the appraisal management company shall provide the real estate appraiser with a proposed contract to perform the appraisal. Specifies information that must be included in a proposed contract. Allows a contract to be offered and accepted through certain electronic means.

Effective: July 1, 2018.

ENGROSSED HOUSE BILL No. 1277

A BILL FOR AN ACT to amend the Indiana Code concerning professions and occupations.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 25-34.1-11-13.5 IS ADDED TO THE INDIANA
2	CODE AS A NEW SECTION TO READ AS FOLLOWS
3	[EFFECTIVE JULY 1, 2018]: Sec. 13.5. (a) Before an appraisal
4	management company may engage a real estate appraiser to
5	perform an appraisal under this chapter, the appraisal
6	management company shall provide the real estate appraiser with
7	a proposed contract to perform the appraisal. The proposed
8	contract must include the following:
9	(1) The order for appraisal.
10	(2) Information delineating the work to be completed.
11	(3) The date when the real estate appraiser must complete the
12	appraisal.
13	(4) The terms and conditions for the payment of the real
14	estate appraiser for the appraisal.
15	(b) A real estate appraiser may accept a proposed contract that
16	is offered and signed, manually or electronically, by the appraisal
17	management company by:



1	(1) signing a written contract and delivering the signed
2	contract to the appraisal management company; or
3	(2) accepting the contract electronically through an electronic
4	mail, facsimile transmission, or digital image to the appraisal
5	management company.
