Citations Affected: Noncode.

Synopsis: Nutritional assistance. Urges the legislative council to assign for study to an appropriate interim study committee the task of studying issues related to eligibility verification and monitoring, identity authentication, and work requirements for participation in the federal Supplemental Nutrition Assistance Program and Medicaid program.

Effective: Upon passage.
