

HOUSE BILL No. 1308

DIGEST OF INTRODUCED BILL

Citations Affected: IC 12-15-1.3-27.

Synopsis: Nutrition supports Medicaid waiver. Requires the office of the secretary of family and social services to apply, not later than October 1, 2025, for approval of a Section 1115 Medicaid demonstration waiver or any other Medicaid waiver to provide coverage for nutrition supports for specified individuals.

Effective: July 1, 2025.

HOUSE BILL No. 1308

A BILL FOR AN ACT to amend the Indiana Code concerning human services.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 12-15-1.3-27 IS ADDED TO THE INDIANA
2 CODE AS A **NEW** SECTION TO READ AS FOLLOWS
3 [EFFECTIVE JULY 1, 2025]: **Sec. 27. (a) As used in this section,**
4 **"nutrition supports" includes the following:**
5 (1) **Case management services.**
6 (2) **Nutrition counseling and instruction.**
7 (3) **Home delivered meals, including medically tailored meals,**
8 **or pantry stocking.**
9 (4) **Nutrition prescriptions.**
10 (5) **Grocery provisions.**
11 (b) **Not later than October 1, 2025, the office of the secretary**
12 **shall apply to the United States Department of Health and Human**
13 **Services for approval of a Section 1115 Medicaid demonstration**
14 **waiver or any other Medicaid waiver to provide Medicaid coverage**
15 **that includes nutrition supports for the following Medicaid**
16 **recipients:**
17 (1) **Medicaid recipients with chronic diseases that are**



- 1 **impacted by nutrition and diet.**
- 2 **(2) Pregnant women.**
- 3 **(3) Children.**
