DIGEST OF INTRODUCED BILL

Synopsis: Table games at racinos. Authorizes table games at racinos. Repeals superseded provisions.

Effective: July 1, 2017.

HOUSE BILL No. 1333

A BILL FOR AN ACT to amend the Indiana Code concerning gaming.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 4-35-2-5, AS AMENDED BY P.L.255-2015,
2 SECTION 21, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2017]: Sec. 5. "Gambling game" means any of the following:
4 (1) A game played on a slot machine approved for wagering under
5 this article by the commission.
6 (2) A game played on a slot machine through the use of a mobile
7 gaming device approved under this article.
8 (3) A table game approved by the commission under
9 ~~IC 4-35-7-19~~; **IC 4-35-7-20**.

10 SECTION 2. IC 4-35-7-7 IS REPEALED [EFFECTIVE JULY 1,
11 2017]. ~~Sec. 7. Except as provided in sections 14 and 19 of this chapter,~~
12 ~~slot machine wagering is the only form of wagering permitted in a~~
13 ~~licensee's slot machine facility.~~

14 SECTION 3. IC 4-35-7-19 IS REPEALED [EFFECTIVE JULY 1,
15 2017]. ~~Sec. 19. (a) After March 1, 2021, and before June 30, 2021, a~~
16 ~~licensee may submit a plan to the commission for conducting wagering~~
17 ~~on table games at the licensee's gambling game facility. The~~

3 (b) In making its determination to authorize wagering on table
4 games; the commission shall consider the potential:

- 5 (1) economic benefits;
- 6 (2) tax revenue;
- 7 (3) number of new jobs; and
- 8 (4) capital investments;

10 based on a plan submitted under subsection (a):

11 (c) After considering a plan submitted under subsection (a) and the
12 criteria described in subsection (b); the commission may authorize
13 wagering on table games at the licensee's gambling game facility:

14 (d) A licensee may not:

- 15 (1) install more gambling games than the number of gambling
16 games proposed in the table game plan submitted to the
17 commission; and
- 18 (2) offer more than two thousand two hundred (2,200) gambling
19 games as provided under section 11(b) of this chapter.

20 SECTION 4. IC 4-35-7-20 IS ADDED TO THE INDIANA CODE
21 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
22 1, 2017]: **Sec. 20. (a) A licensee may submit a plan to the
23 commission for conducting wagering on table games at the
24 licensee's gambling game facility. Upon receipt of an appropriate
25 plan, the commission shall authorize wagering on table games at
26 the licensee's gambling game facility. Except as provided in
27 subsection (b), a licensee may not install more table game positions
28 than the number of positions proposed in the table game plan
29 submitted to the commission.**

30 (b) A licensee may install additional table game positions with
31 the approval of the commission.
