

HOUSE BILL No. 1362

DIGEST OF INTRODUCED BILL

Citations Affected: IC 4-33; IC 10-11-2-35.

Synopsis: State law enforcement salaries. Provides salary increases of 72% for the police employees of the state police and the gaming agents and gaming control officers of the Indiana gaming commission. (Current law provides that salary increases for police employees of state police also require corresponding increases for the salaries of enforcement officers of the alcohol and tobacco commission and enforcement officers of the department of natural resources.) Makes appropriations.

Effective: Upon passage; July 1, 2016.

HOUSE BILL No. 1362

A BILL FOR AN ACT to amend the Indiana Code concerning public safety and to make an appropriation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 4-33-4.5-6 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
3 UPON PASSAGE]: **Sec. 6. The commission shall revise the salary**
4 **matrix described under section 5 of this chapter that is in effect on**
5 **January 1, 2016, by increasing the salary entry for each rank and**
6 **term of service in the salary matrix by seventy-two percent (72%),**
7 **effective July 1, 2016.**

8 SECTION 2. IC 4-33-20-15 IS ADDED TO THE INDIANA CODE
9 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
10 UPON PASSAGE]: **Sec. 15. The commission shall revise the salary**
11 **schedule for gaming control officers that is in effect on January 1,**
12 **2016, by increasing the salary for each rank and term of service by**
13 **seventy-two percent (72%), effective July 1, 2016.**

14 SECTION 3. IC 10-11-2-35 IS ADDED TO THE INDIANA CODE
15 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE
16 UPON PASSAGE]: **Sec. 35. (a) Notwithstanding section 8(c) of this**
17 **chapter, the state police board shall revise the salary matrix**



1 described under section 13 of this chapter that is in effect on
2 January 1, 2016, by increasing the salary entry for each rank and
3 term of service in the salary matrix by seventy-two percent (72%),
4 effective July 1, 2016.

5 (b) Notwithstanding section 8(c) of this chapter, the state police
6 board shall revise the salary matrix described under section 27 of
7 this chapter that is in effect on January 1, 2016, by increasing the
8 salary entry for each rank and term of service in the salary matrix
9 by seventy-two percent (72%), effective July 1, 2016.

10 (c) Notwithstanding section 8(c) of this chapter, the state police
11 board shall revise the salary matrix described under section 28.5
12 of this chapter that is in effect on January 1, 2016, by increasing
13 the salary entry for each rank and term of service in the salary
14 matrix by seventy-two percent (72%), effective July 1, 2016.

15 SECTION 4. [EFFECTIVE JULY 1, 2016] (a) There is
16 appropriated from the state general fund to the state police
17 department an amount sufficient to pay the increased salaries and
18 compensation required by IC 10-11-2-35, as added by this act, for
19 the state fiscal year beginning July 1, 2016.

20 (b) The appropriation in subsection (a) is in addition to the
21 appropriations to the state police department set forth in
22 P.L.213-2015 for the payment of salaries and compensation for the
23 state fiscal year beginning July 1, 2016.

24 (c) There is appropriated from the state general fund to the
25 department of natural resources an amount sufficient to pay the
26 increased salaries and compensation of enforcement officers
27 required by IC 10-11-2-35, as added by this act, and IC 14-9-8-28
28 for the state fiscal year beginning July 1, 2016.

29 (d) The appropriation in subsection (c) is in addition to the
30 appropriations to the department of natural resources set forth in
31 P.L.213-2015 for the payment of salaries and compensation of
32 enforcement officers for the state fiscal year beginning July 1,
33 2016.

34 (e) There is appropriated from the state general fund to the
35 alcohol and tobacco commission an amount sufficient to pay the
36 increased salaries and compensation of enforcement officers
37 required by IC 10-11-2-35, as added by this act, IC 14-9-8-28, and
38 IC 7.1-2-2-13 for the state fiscal year beginning July 1, 2016.

39 (f) The appropriation in subsection (e) is in addition to the
40 appropriations to the alcohol and tobacco commission set forth in
41 P.L.213-2015 for the payment of salaries and compensation of
42 enforcement officers for the state fiscal year beginning July 1,

2 **(g) There is appropriated from the state general fund to the**
3 **Indiana gaming commission an amount sufficient to pay the**
4 **increased salaries and compensation of gaming agents required by**
5 **IC 4-33-4.5-6, as added by this act, for the state fiscal year**
6 **beginning July 1, 2016.**
7 **(h) The appropriation in subsection (g) is in addition to the**
8 **appropriations to the Indiana gaming commission set forth in**
9 **P.L.213-2015 for the payment of salaries and compensation of**
10 **gaming agents for the state fiscal year beginning July 1, 2016.**
11 **(i) There is appropriated from the charity gaming enforcement**
12 **fund established by IC 4-32.2-7-3 to the Indiana gaming**
13 **commission an amount sufficient to pay the increased salaries and**
14 **compensation of gaming control officers required by**
15 **IC 4-33-20-15, as added by this act, for the state fiscal year**
16 **beginning July 1, 2016.**
17 **(j) The appropriation in subsection (i) is in addition to the**
18 **appropriations to the Indiana gaming commission set forth in**
19 **P.L.213-2015 for the payment of salaries and compensation of**
20 **gaming control officers for the state fiscal year beginning July 1,**
21 **2016.**
22 **(k) This SECTION expires July 1, 2017.**
23 **SECTION 5. An emergency is declared for this act.**
