DIGEST OF HB 1369 (Updated January 24, 2017 8:46 am - DI 84)

**Citations Affected:** IC 4-1.

**Synopsis:** Unnecessary, unused law reports. Requires every state agency to compile and report to the select committee on government reduction a list of all state laws administered by the state agency that the state agency considers to be in need of change because the laws are no longer necessary or used.

**Effective:** July 1, 2017.

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 2016 Regular Session of the General Assembly.

## HOUSE BILL No. 1369

---

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 4-1-13 IS ADDED TO THE INDIANA CODE AS  
2 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY  
3 1, 2017]:  
4 **Chapter 13. Government Reduction Reports**  
5 **Sec. 1. (a) As used in this chapter, "state agency" means every**  
6 **agency, board, commission, department, bureau, or other entity of**  
7 **the administrative branch of Indiana state government.**  
8 **(b) The term includes every agency, board, commission,**  
9 **department, bureau, or other entity that is the responsibility of the**  
10 **auditor of state, treasurer of state, secretary of state, attorney**  
11 **general, and superintendent of public instruction.**  
12 **(c) The term includes a state educational institution.**  
13 **Sec. 2. (a) Not later than November 1 of each year, each state**  
14 **agency shall:**  
15 **(1) compile a list of all state laws administered by the state**  
16 **agency that the state agency considers to be in need of**  
17 **substantive amendment or repeal because the laws are no**

1           **longer necessary or used; and**  
2           **(2) report the list compiled under subdivision (1) to the select**  
3           **committee on government reduction in an electronic format**  
4           **under IC 5-14-6.**  
5           **(b) A list compiled under subsection (a) must include the:**  
6           **(1) state agency's rationale for each substantive amendment**  
7           **or repeal; and**  
8           **(2) manner in which the state agency suggests each**  
9           **substantive amendment should be drafted for inclusion in**  
10           **amending legislation.**
