Synopsis: Awareness of human trafficking. Requires gas stations to display human trafficking awareness posters.

Effective: July 1, 2025.

HOUSE BILL No. 1416

A BILL FOR AN ACT to amend the Indiana Code concerning trade regulation.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 24-4-24.5 IS ADDED TO THE INDIANA CODE
- 2 AS A **NEW** CHAPTER TO READ AS FOLLOWS [EFFECTIVE
- 3 JULY 1, 2025]:
- 4 **Chapter 24.5. Human Trafficking Awareness in Gas Stations**
- 5 **Sec. 1. As used in this chapter, "automotive fuel" includes diesel**
- 6 **fuel, gasohol, or gasoline.**
- 7 **Sec. 2. As used in this chapter, "gas station" means an**
- 8 **establishment that is primarily engaged in the retail sale of**
- 9 **automotive fuels.**
- 10 **Sec. 3. The owner or operator of a gas station shall display:**
- 11 **(1) in all public restroom facilities; and**
- 12 **(2) in at least one (1) other public location;**
- 13 **on the gas station premises, human trafficking awareness posters.**
- 14 **Sec. 4. The human trafficking awareness posters must contain**
- 15 **the following information:**
- 16 **(1) A description of human trafficking.**
- 17 **(2) Information about indicators of human trafficking, such**



- 1 as restricted freedom of movement and signs of physical
- 2 abuse.
- 3 (3) The telephone numbers for:
- 4 (A) law enforcement; and
- 5 (B) a human trafficking hotline.
