HOUSE BILL No. 1443

DIGEST OF HB 1443 (Updated February 5, 2019 1:58 pm - DI 116)

Citations Affected: Noncode.

Synopsis: Task force to study schools for the deaf and blind. Establishes the Indiana Schools for the Deaf and the Blind or Visually Impaired task force (task force) to evaluate and make recommendations to the budget committee relating to the operation of the physical plants of the Indiana School for the Deaf and the Indiana School for the Blind or Visually Impaired. Provides that the task force shall make its final recommendations to the budget committee on or before December 1, 2020. Establishes the task force advisory committee (advisory committee) to advise the task force on matters necessary for the task force to carry out its responsibilities. Provides that the department of administration shall provide staffing and administrative support for the task force and the advisory committee.

HOUSE BILL No. 1443

A BILL FOR AN ACT concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **The definitions**
2 **used in IC 20 apply throughout this SECTION.**
3 (b) **As used in this SECTION, "advisory committee" refers to**
4 **the task force advisory committee established in subsection (g).**
5 (c) **As used in this SECTION, "task force" refers to the Indiana**
6 **Schools for the Deaf and the Blind or Visually Impaired task force**
7 **established in subsection (d).**
8 (d) **The Indiana Schools for the Deaf and the Blind or Visually**
9 **Impaired task force is established to evaluate and make**
10 **recommendations to the budget committee relating to the**
11 **operation of the physical plants of the Indiana School for the Deaf**
12 **and the Indiana School for the Blind or Visually Impaired. The**
13 **task force consists of the following members:**
14 (1) **The superintendent of the Indiana School for the Deaf, or**
15 **the superintendent's designee.**
16 (2) **The superintendent of the Indiana School for the Blind or**
17 **Visually Impaired, or the superintendent's designee.**
18 (3) **The commissioner of the department of administration**

1 created by IC 4-13-1-2, or the commissioner's designee.

2 (4) One (1) member, who is a current or former student of the
3 Indiana School for the Deaf, appointed by the governor.

4 (5) One (1) member, who is a current or former student of the
5 Indiana School for the Blind or Visually Impaired, appointed
6 by the governor.

7 (6) One (1) member, who is a parent of a hearing impaired
8 child, and:

9 (A) the parent is a member of Hear Indiana
10 (HearIndiana.org); or

11 (B) the child received services from Indiana First Steps;
12 appointed by the governor.

13 (7) One member, nominated from Indiana Disability Rights
14 and appointed by the governor.

15 (8) One (1) member of the senate, appointed by the president
16 pro tempore of the senate.

17 (9) One (1) member of the house of representatives, appointed
18 by the speaker of the house of representatives.

19 (e) The chairperson of the legislative council during the 2019
20 interim shall appoint one (1) of the members under subsection (d)
21 to serve as chairperson of the task force. The task force shall meet
22 at the call of the chairperson of the task force. Each member
23 appointed under subsection (d) serves at the will of the member's
24 appointing authority. A quorum of the task force consists of five (5)
25 members. The affirmative vote of at least five (5) members is
26 necessary for the task force to approve the final report and for
27 other official action of the task force.

28 (f) The task force shall do the following:

29 (1) On or before December 1, 2019, make recommendations
30 to the budget committee as to whether the Indiana School for
31 the Deaf and the Indiana School for the Blind or Visually
32 Impaired should be combined into a single campus.

33 (2) If the task force does not recommend combining the
34 schools described in subdivision (1) into a single campus, the
35 task force shall evaluate and make recommendations to the
36 budget committee regarding how to implement master plans
37 for the Indiana School for the Deaf and the Indiana School for
38 the Blind or Visually Impaired for the next:

39 (A) five (5) years;

40 (B) ten (10) years; and

41 (C) fifteen (15) years.

42 (3) If the task force recommends combining the schools



1 described in subdivision (1) into a single campus, the task
 2 force shall evaluate and make recommendations to the budget
 3 committee regarding potential options for combining the
 4 campuses of the schools described in subdivision (1) and
 5 include a cost analysis of each potential solution that
 6 incorporates the savings projected by not operating two (2)
 7 separate campuses.

8 (4) Make final recommendations that comply with Article 9,
 9 Section 1 of the Constitution of the State of Indiana to the
 10 budget committee on or before December 1, 2020.

11 (g) The task force advisory committee is established to advise
 12 the task force, in a manner prescribed by the task force, on matters
 13 necessary for the task force to carry out its responsibilities under
 14 this SECTION. The advisory committee is composed of the
 15 following members:

16 (1) The operations director for the Indiana School for the
 17 Deaf.

18 (2) The operations director for the Indiana School for the
 19 Blind or Visually Impaired.

20 (3) The budget director, or the budget director's designee.

21 (4) The commissioner of the commission for higher education,
 22 or the commissioner's designee.

23 (5) The superintendent of public instruction, or the
 24 superintendent of public instruction's designee.

25 (6) One (1) member representing the construction industry,
 26 appointed by the governor.

27 (7) One (1) member who is a parent of a current student at the
 28 Indiana School for the Deaf, appointed by the governor.

29 (8) One (1) member who is a parent of a current student at the
 30 Indiana School for the Blind or Visually impaired, appointed
 31 by the governor.

32 (h) The chairperson of the legislative council during the 2019
 33 interim shall appoint one (1) of the members under subsection (g)
 34 to serve as chairperson of the advisory committee. The advisory
 35 committee shall meet at the call of the chairperson of the task force
 36 or the chairperson of the advisory committee. Each member
 37 appointed by the governor under subsection (g) serves at the will
 38 of the governor. A quorum of the advisory committee consists of
 39 five (5) members. The advisory committee shall make
 40 recommendations and advise the task force in a manner prescribed
 41 by the chairperson of the task force.

42 (i) The department of administration created by IC 4-13-1-2



1 shall provide staffing and administrative support for the task force
2 and the advisory committee necessary for the task force and
3 advisory committee to carry out their duties and responsibilities
4 under this SECTION.

5 (j) Each member of the task force or advisory committee who is
6 not a state employee or a member of the general assembly is not
7 entitled to the minimum salary per diem or reimbursement for
8 traveling expenses and other expenses. Each member of the task
9 force or advisory committee who is a state employee but who is not
10 a member of the general assembly is entitled to reimbursement for
11 traveling expenses and other expenses actually incurred in
12 connection with the member's duties, as provided in the state travel
13 policies and procedures established by the department of
14 administration and approved by the budget agency. Each member
15 of the task force who is a member of the general assembly is
16 entitled to receive the same per diem, mileage, and travel
17 allowances paid to legislative members of interim study committees
18 established by the legislative council. Per diem, mileage, and travel
19 allowances paid under this subsection shall be paid from
20 appropriations made to the legislative council or the legislative
21 services agency.

22 (k) Meetings of the task force and the advisory committee must
23 comply with IC 5-14-1.5.

24 (l) This SECTION expires January 1, 2021.

25 SECTION 2. An emergency is declared for this act.
