HOUSE BILL No. 1443

DIGEST OF HB 1443 (Updated March 27, 2019 5:31 pm - DI 110)

Citations Affected: Noncode.

Synopsis: Task force to study schools for the deaf and blind. Establishes the Indiana Schools for the Deaf and the Blind or Visually Impaired task force (task force) to evaluate and make recommendations to the budget committee relating to the operation of the physical plants of the Indiana School for the Deaf and the Indiana School for the Blind or Visually Impaired. Provides that the task force shall make its final recommendations to the budget committee on or before December 1, 2020. Establishes the task force advisory committee (advisory committee) to advise the task force on matters necessary for the task force to carry out its responsibilities. Provides that the department of administration shall provide staffing and administrative support for the task force and the advisory committee.

Effective: Upon passage.

ENGROSSED HOUSE BILL No. 1443

A BILL FOR AN ACT concerning education.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. [EFFECTIVE UPON PASSAGE] (a) **The definitions**
2 **used in IC 20 apply throughout this SECTION.**
3 (b) **As used in this SECTION, "advisory committee" refers to**
4 **the task force advisory committee established in subsection (g).**
5 (c) **As used in this SECTION, "task force" refers to the Indiana**
6 **Schools for the Deaf and the Blind or Visually Impaired task force**
7 **established in subsection (d).**
8 (d) **The Indiana Schools for the Deaf and the Blind or Visually**
9 **Impaired task force is established to evaluate and make**
10 **recommendations to the budget committee relating to the**
11 **operation of the physical plants of the Indiana School for the Deaf**
12 **and the Indiana School for the Blind or Visually Impaired. The**
13 **task force consists of the following members:**
14 (1) **The superintendent of the Indiana School for the Deaf, or**
15 **the superintendent's designee.**
16 (2) **The superintendent of the Indiana School for the Blind or**
17 **Visually Impaired, or the superintendent's designee.**
18 (3) **The commissioner of the department of administration**

- 2 (4) One (1) member, who is an alumnus of the Indiana School
- 3 for the Deaf, appointed by the governor.
- 4 (5) One (1) member, who is an alumnus of the Indiana School
- 5 for the Blind or Visually Impaired, appointed by the
- 6 governor.
- 7 (6) One (1) member who is a parent of a current full-time
- 8 student at the Indiana School for the Deaf, appointed by the
- 9 governor.
- 10 (7) One (1) member who is a parent of a current full-time
- 11 student at the Indiana School for the Blind or Visually
- 12 Impaired, appointed by the governor.
- 13 (8) One (1) member of the senate, appointed by the president
- 14 pro tempore of the senate.
- 15 (9) One (1) member of the house of representatives, appointed
- 16 by the speaker of the house of representatives.
- 17 (e) The chairperson of the legislative council during the 2019
- 18 interim shall appoint one (1) of the members under subsection (d)
- 19 to serve as chairperson of the task force. The task force shall meet
- 20 at the call of the chairperson of the task force. Each member
- 21 appointed under subsection (d) serves at the will of the member's
- 22 appointing authority. A quorum of the task force consists of five (5)
- 23 members. The affirmative vote of at least five (5) members is
- 24 necessary for the task force to approve the final report and for
- 25 other official action of the task force.
- 26 (f) The task force shall do the following:
- 27 (1) On or before December 1, 2019, make recommendations
- 28 to the budget committee as to whether the Indiana School for
- 29 the Deaf and the Indiana School for the Blind or Visually
- 30 Impaired should be combined into a single campus.
- 31 (2) If the task force does not recommend combining the
- 32 schools described in subdivision (1) into a single campus, the
- 33 task force shall evaluate and make recommendations to the
- 34 budget committee regarding how to implement master plans
- 35 for the Indiana School for the Deaf and the Indiana School for
- 36 the Blind or Visually Impaired for the next:
- 37 (A) five (5) years;
- 38 (B) ten (10) years; and
- 39 (C) fifteen (15) years.
- 40 (3) If the task force recommends combining the schools
- 41 described in subdivision (1) into a single campus, the task
- 42 force shall evaluate and make recommendations to the budget



1 committee regarding potential options for combining the
 2 campuses of the schools described in subdivision (1) and
 3 include a cost analysis of each potential solution that
 4 incorporates the savings projected by not operating two (2)
 5 separate campuses.

6 (4) Make final recommendations that comply with Article 9,
 7 Section 1 of the Constitution of the State of Indiana to the
 8 budget committee on or before December 1, 2020.

9 (g) The task force advisory committee is established to advise
 10 the task force, in a manner prescribed by the task force, on matters
 11 necessary for the task force to carry out its responsibilities under
 12 this SECTION. The advisory committee is composed of the
 13 following members:

14 (1) The operations director for the Indiana School for the
 15 Deaf.

16 (2) The operations director for the Indiana School for the
 17 Blind or Visually Impaired.

18 (3) The budget director, or the budget director's designee.

19 (4) The commissioner of the commission for higher education,
 20 or the commissioner's designee.

21 (5) The superintendent of public instruction, or the
 22 superintendent of public instruction's designee.

23 (6) One (1) member representing the construction industry,
 24 appointed by the governor.

25 (7) One (1) member who is a parent of a student who:

26 (A) is deaf or hard of hearing; and

27 (B) attends a public school that is not a charter school;
 28 appointed by the governor.

29 (8) One (1) member who is a parent of a student who:

30 (A) is blind; and

31 (B) attends a public school that is not a charter school;
 32 appointed by the governor.

33 (9) One (1) member, nominated by Indiana Disability Rights
 34 and appointed by the governor.

35 (h) The chairperson of the legislative council during the 2019
 36 interim shall appoint one (1) of the members under subsection (g)
 37 to serve as chairperson of the advisory committee. The advisory
 38 committee shall meet at the call of the chairperson of the task force
 39 or the chairperson of the advisory committee. Each member
 40 appointed by the governor under subsection (g) serves at the will
 41 of the governor. A quorum of the advisory committee consists of
 42 five (5) members. The advisory committee shall make



1 recommendations and advise the task force in a manner prescribed
2 by the chairperson of the task force.

3 (i) The department of administration created by IC 4-13-1-2
4 shall provide staffing and administrative support for the task force
5 and the advisory committee necessary for the task force and
6 advisory committee to carry out their duties and responsibilities
7 under this SECTION.

8 (j) Each member of the task force or advisory committee who is
9 not a state employee or a member of the general assembly is not
10 entitled to the minimum salary per diem or reimbursement for
11 traveling expenses and other expenses. Each member of the task
12 force or advisory committee who is a state employee but who is not
13 a member of the general assembly is entitled to reimbursement for
14 traveling expenses and other expenses actually incurred in
15 connection with the member's duties, as provided in the state travel
16 policies and procedures established by the department of
17 administration and approved by the budget agency. Each member
18 of the task force who is a member of the general assembly is
19 entitled to receive the same per diem, mileage, and travel
20 allowances paid to legislative members of interim study committees
21 established by the legislative council. Per diem, mileage, and travel
22 allowances paid under this subsection shall be paid from
23 appropriations made to the legislative council or the legislative
24 services agency.

25 (k) Meetings of the task force and the advisory committee must
26 comply with IC 5-14-1.5.

27 (l) This SECTION expires January 1, 2021.

28 SECTION 2. An emergency is declared for this act.

"(6) One (1) member who is a parent of a current full-time student at the Indiana School for the Deaf, appointed by the governor.

(7) One (1) member who is a parent of a current full-time student at the Indiana School for the Blind or Visually Impaired, appointed by the governor."

Page 3, delete lines 27 through 31, begin a new line block indented and insert:

"(7) One (1) member who is a parent of a student who:

(A) is deaf or hard of hearing; and

(B) attends a public school that is not a charter school; appointed by the governor.

(8) One (1) member who is a parent of a student who:

(A) is blind; and

(B) attends a public school that is not a charter school; appointed by the governor.

(9) One (1) member, nominated by Indiana Disability Rights and appointed by the governor."
