DIGEST OF HB 1452 (Updated March 23, 2015 12:34 pm - DI 92)

Citations Affected: IC 4-4; IC 4-20.5; IC 5-22; IC 6-1.1; IC 14-8; IC 14-9; IC 14-18; IC 14-19; IC 14-22; IC 14-28; IC 25-36.5; noncode.

Synopsis: Natural resources matters. Allows the department of administration to sell abandoned railroad corridor property to an adjacent landowner under certain conditions. Adds supplies purchased for resale at properties owned or managed by the department of natural resources (department) to the purchases exempt from the public purchasing requirements. Allows the state forester to use a geographic information system for classified land inspections if a landowner chooses to not accompany the state forester on the inspection. Provides that certain information concerning an endangered species may be kept confidential. Allows the director of the department to issue an order vacating a public highway within property owned or managed by the department. Provides that rules adopted by the department concerning the use of motorized carts at state parks and recreation areas must comply with the Americans with Disabilities Act. Allows the natural resources commission (commission) to set the compensation rate for the development of game bird habitats. Specifies that certain restrictions on the transfer of fish do not apply to the roe bearing fish

that are separately regulated as roe bearing fish. Allows licenses, stamps, and permits of the department that are purchased electronically to be validated through an electronic affirmation. Provides that trout and salmon stamps are electronically generated. Provides that a duplicate license to hunt, trap, or fish is valid only with the signature or electronic affirmation of the licensee. Establishes the date by which a fur buyer's report must be submitted to the department. Provides that a law enforcement officer may seize certain animals and items if certain laws are violated. (Current law requires seizure.) Allows certain floodway permits to be renewed for five years. Transfers control of the flood control revolving fund from the commission to the Indiana finance authority. Increases the amount of a surety bond that a timber buyer must pay to engage in the business of timber buying in Indiana. Increases the maximum security required for a timber buyer's license to \$50,000 beginning January 1, 2017. Removes the requirement that a timber buyer designate a principle agent. Makes conforming and stylistic changes.

ENGROSSED HOUSE BILL No. 1452

A BILL FOR AN ACT to amend the Indiana Code concerning natural and cultural resources.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 4-4-10.9-1.2, AS AMENDED BY P.L.233-2013,
2 SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2015]: Sec. 1.2. "Affected statutes" means all statutes that
4 grant a power to or impose a duty on the authority, including but not
5 limited to IC 4-4-11, IC 4-4-11.4, IC 4-4-11.6, IC 4-4-21, IC 4-13.5,
6 IC 5-1-16, IC 5-1-16.5, IC 5-1-17.5, IC 8-9.5, IC 8-14.5, IC 8-15,
7 IC 8-15.5, IC 8-16, IC 13-18-13, IC 13-18-21, IC 13-19-5, ~~and~~
8 IC 14-14, **and IC 14-28-5.**
- 9 SECTION 2. IC 4-20.5-7-11, AS AMENDED BY P.L.33-2011,
10 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
11 JULY 1, 2015]: Sec. 11. (a) **Except as provided in subsection (f)**, the
12 department may sell the property through any of the following:
13 (1) Competitive bids.
14 (2) By auction.
15 (3) By request for proposals.

1 (b) The department may enter into negotiations under this section
 2 with the respondent who has made the highest offer only if the
 3 negotiations are documented. The negotiation documentation must
 4 include the following:

5 (1) A log of the date and time of each meeting with a respondent.
 6 The log must include the identity of the respondent.

7 (2) A description of the nature of all communications with each
 8 respondent.

9 (3) Subject to subsection (d), a copy of all written
 10 communications, including electronic communications, with each
 11 respondent.

12 (c) Except as provided in subsection (d), the contents of the contract
 13 file concerning a sale under this section are subject to public
 14 inspection.

15 (d) Proprietary information included with a response, including
 16 trade secrets, manufacturing processes, and financial information that
 17 was not required to be made available for public inspection by the
 18 terms of the invitation for bids, live auction, or request for proposals,
 19 is not subject to public inspection.

20 (e) The negotiation documentation is subject to public inspection
 21 under this section only after the transfer of the property.

22 **(f) If the department owns abandoned railroad corridor
 23 property and the abandoned railroad corridor property:**

24 **(1) has a value of not more than ten thousand dollars
 25 (\$10,000); and**

26 **(2) abuts the property of an adjacent property owner;
 27 then the department may sell the abandoned railroad corridor
 28 property to the adjacent property owner at the value of the
 29 appraised property.**

30 SECTION 3. IC 5-22-1-2, AS AMENDED BY P.L.11-2011,
 31 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 32 JULY 1, 2015]: Sec. 2. Except as provided in this article, this article
 33 does not apply to the following:

34 (1) The commission for higher education.

35 (2) A state educational institution. However, IC 5-22-5-9 and
 36 IC 5-22-15 apply to a state educational institution.

37 (3) Military officers and military and armory boards of the state.

38 (4) An entity established by the general assembly as a body
 39 corporate and politic. However, IC 5-22-15 applies to a body
 40 corporate and politic.

41 (5) A local hospital authority under IC 5-1-4.

42 (6) A municipally owned utility under IC 8-1-11.1 or IC 8-1.5.



- 1 (7) Hospitals established and operated under IC 16-22-1 through
 2 IC 16-22-5, IC 16-22-8, IC 16-23-1, or IC 16-24-1.
 3 (8) A library board under IC 36-12-3-16(b).
 4 (9) A local housing authority under IC 36-7-18.
 5 (10) Tax exempt Indiana nonprofit corporations leasing and
 6 operating a city market owned by a political subdivision.
 7 (11) A person paying for a purchase or lease with funds other than
 8 public funds.
 9 (12) A person that has entered into an agreement with a
 10 governmental body under IC 5-23.
 11 (13) A municipality for the operation of municipal facilities used
 12 for the collection, treatment, purification, and disposal in a
 13 sanitary manner of liquid and solid waste, sewage, night soil, and
 14 industrial waste.
 15 (14) The department of financial institutions established by
 16 IC 28-11-1-1.
 17 (15) The insurance commissioner in retaining an examiner for
 18 purposes of IC 27-1-3.1-9.

19 **(16) The department of natural resources for the procurement**
 20 **of supplies purchased for resale at properties owned or**
 21 **managed by the department of natural resources.**

22 SECTION 4. IC 6-1.1-6-19, AS AMENDED BY P.L.151-2012,
 23 SECTION 5, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 24 JULY 1, 2015]: Sec. 19. At least once every seven (7) years the state
 25 forester, or the state forester's deputy, shall inspect each parcel of land
 26 which is classified as native forest land, a forest plantation, or
 27 wildlands. On each inspection trip the state forester, or the state
 28 forester's deputy, shall, if possible, have the owner go over the parcel
 29 with the state forester and shall point out to the owner any needed
 30 improvement. **If the landowner chooses not to accompany the state**
 31 **forester in person, the state forester may use a geographic**
 32 **information system (GIS) or other remote sensing technology to**
 33 **conduct the inspection.** In addition, the state forester shall give the
 34 owner a written report of the inspection and the state forester's
 35 recommendations. A permanent record of each inspection shall be
 36 maintained in the office of the state forester.

37 SECTION 5. IC 14-8-2-16.4 IS ADDED TO THE INDIANA CODE
 38 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 39 1, 2015]: **Sec. 16.4. "Authority", for purposes of IC 14-28-5, has the**
 40 **meaning set forth in IC 14-28-5-0.5.**

41 SECTION 6. IC 14-8-2-85 IS AMENDED TO READ AS
 42 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 85. **(a) "Endangered**



1 **species", for purposes of IC 14-9-2-5, has the meaning set forth in**
 2 **IC 14-9-2-5(a).**

3 (b) "Endangered species", for purposes of IC 14-22-34, has the
 4 meaning set forth in IC 14-22-34-1.

5 SECTION 7. IC 14-9-2-5 IS ADDED TO THE INDIANA CODE
 6 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
 7 1, 2015]: **Sec. 5. (a) As used in this section, "endangered species"**
 8 **means the following:**

9 (1) **An endangered species as defined by IC 14-22-34-1.**

10 (2) **A native plant species classified by the division of nature**
 11 **preserves as endangered or threatened.**

12 (b) **Information that provides the specific or general location of**
 13 **an endangered species or information that, if disclosed, could have**
 14 **a detrimental effect on an endangered species may be kept**
 15 **confidential for purposes of IC 5-14-3-4 at the discretion of the**
 16 **director.**

17 SECTION 8. IC 14-18-12-3 IS AMENDED TO READ AS
 18 FOLLOWS [EFFECTIVE JULY 1, 2015]: **Sec. 3. (a) Whenever the**
 19 **director determines that the proper operation or administration of:**

20 (1) a state park;

21 (2) a state forest;

22 (3) a state game preserve; ~~or~~

23 (4) a scenic or historic place; **or**

24 (5) **any other property owed or managed by the department;**
 25 **necessitates the abandonment of all or part of a public highway, except**
 26 **a state highway, that is located on or within the boundaries of the**
 27 **property, the director may issue an order vacating all or part of the**
 28 **public highway.**

29 (b) The director shall have a copy of the order posted in five (5)
 30 conspicuous places in the township where the public highway is
 31 located fifteen (15) days before the order takes effect.

32 (c) If any privately owned land would become inaccessible by a
 33 public highway due to the order and vacation, as much of the highway
 34 that provides the only public access to and outlet from the land is not
 35 vacated as long as the condition exists.

36 SECTION 9. IC 14-19-1-1, AS AMENDED BY P.L.225-2005,
 37 SECTION 15, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 38 JULY 1, 2015]: **Sec. 1. The department shall do the following:**

39 (1) Have the custody of and maintain the parks, preserves, forests,
 40 reservoirs, and memorials owned by the state.

41 (2) Adopt the necessary rules under IC 4-22-2 to secure
 42 enforcement of this title, which must include provisions for the



1 use of motorized carts during the hours specified in
 2 IC 9-21-7-2(a)(1) at state parks and recreation areas by an
 3 individual who is the holder of a driver's license and who:

4 (A) is at least sixty-five (65) years of age; or

5 (B) has a **mobility** disability as defined by the federal **Social**
 6 **Security Administration guidelines (42 U.S.C. 416).**

7 **Americans with Disabilities Act (42 U.S.C. 12101 et seq).**

8 **Rules adopted under this subdivision must comply with the**
 9 **provisions for mobility devices as described in 28 CFR 35.137.**

10 (3) Prepare, print, post, or distribute printed matter relating to the
 11 state parks and preserves.

12 (4) Subject to the approval of the governor, purchase land for
 13 parks or preserves and scenic and historic places. For the purpose
 14 of acquiring land for parks or preserves and scenic and historic
 15 places, the commission may exercise the power of eminent
 16 domain in the manner provided in IC 14-17-3.

17 (5) Accept in the name of the state by gift or devise the fee or
 18 other estate in land or scenic or historic places.

19 (6) Employ, with the approval of the authorities having control of
 20 a state penal institution, the convicts committed to a penal
 21 institution for the purpose of producing or planting trees, clearing,
 22 improving, repairing, draining, or developing land purchased or
 23 acquired by the state for parks or preserves or as scenic or historic
 24 places.

25 (7) Have the custody of all abstracts of title, papers, contracts, or
 26 related memoranda except original deeds to the state, for land
 27 purchased or received for parks or preserves or for scenic or
 28 historic purposes under this section.

29 (8) Cooperate with:

30 (A) the department of environmental management;

31 (B) other state agencies; and

32 (C) local units of government;

33 to protect the water and land of Indiana from pollution.

34 (9) Have general charge of the navigable water of Indiana.

35 SECTION 10. IC 14-22-8-7 IS AMENDED TO READ AS
 36 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 7. (a) The department
 37 shall contract for the development of game bird habitats in Indiana.
 38 Each contract must:

39 (1) be for at least three (3) years; and

40 (2) provide a plan for the development of habitat for at least one

41 (1) species of game bird.

42 (b) The department may seek the cooperation of federal agencies



1 such as the Agricultural Stabilization and Conservation Service or the
 2 Natural Resources Conservation Service in the development of habitat
 3 plans and compensation for habitat plans. Monetary compensation may
 4 not exceed ~~one hundred dollars (\$100)~~ **the rate** per acre per year **as**
 5 **determined by the commission** and each contract may provide that
 6 the site be open for regulated public game bird hunting.

7 (c) The department may purchase land in Indiana from willing
 8 sellers for the development of game bird habitats.

9 SECTION 11. IC 14-22-9-7 IS AMENDED TO READ AS
 10 FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 7. (a) This section does
 11 not apply to the sale of fish produced in private ponds for sale or for
 12 breeding and stocking purposes, **or for roe bearing species listed in**
 13 **IC 14-22-13-2.5(a)**, if the owner obtains a permit from the director
 14 under the rules adopted by the department and conditions provided in
 15 the permit.

16 (b) A person may not sell, barter, or exchange, offer to sell, barter,
 17 or exchange, or purchase or offer to purchase fish protected by law,
 18 whether taken in Indiana, the boundary waters of the state, or some
 19 other state and brought into Indiana, except as otherwise provided in
 20 this article. Restaurants, hotels, boardinghouses, or eating houses may
 21 prepare and serve during the open season to:

22 (1) a guest, patron, or boarder; and

23 (2) the family of the guest, patron, or boarder;

24 fish legally taken in open season in Indiana by the guest, patron, or
 25 boarder.

26 (c) Except **for roe bearing species listed in IC 14-22-13-2.5(a) or**
 27 as specifically prohibited by law, a person may sell a species of
 28 hatchery reared fish or fish legally taken outside Indiana under a valid
 29 commercial fishing license or regulation, dead or alive, dressed or
 30 undressed, or partly dressed under the rules that the department and the
 31 state department of health prescribe if the fish are tagged or labeled in
 32 a manner that specifically identifies the following:

33 (1) The name and address of the seller.

34 (2) The hatchery.

35 (3) The commercial fishing license or regulation.

36 (d) A person may not import and sell a live species of fish that has
 37 not been approved by the director without a permit from the director for
 38 this activity.

39 SECTION 12. IC 14-22-11-3, AS AMENDED BY P.L.225-2005,
 40 SECTION 20, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 41 JULY 1, 2015]: Sec. 3. (a) An applicant for a hunting, trapping, or
 42 fishing license must provide the applicant's Social Security number in



1 order to obtain the license. Social Security numbers acquired under this
 2 subsection shall be kept confidential and used only to carry out the
 3 purposes of the Title IV-D program.

4 (b) The director and agents appointed by the director as authorized
 5 representatives of the department shall issue hunting, trapping, and
 6 fishing licenses.

7 (c) The clerk of the circuit court in each county may issue hunting,
 8 trapping, and fishing licenses.

9 (d) Each hunting, trapping, or fishing license must be in a form
 10 prescribed by the director. The director may furnish the clerks and
 11 agents with all necessary equipment needed to issue a license.

12 (e) All licenses, stamps, or permits purchased electronically are
 13 valid only with the original signature **or electronic affirmation** of the
 14 licensee on the form **or device** prescribed by the director. The
 15 licensee's signature **or electronic affirmation** serves as an affidavit
 16 that the license, stamp, or permit information is true and accurate.

17 (f) A person who violates the confidentiality requirement of
 18 subsection (a) commits a Class A infraction.

19 SECTION 13. IC 14-22-11-8, AS AMENDED BY P.L.18-2009,
 20 SECTION 2, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 21 JULY 1, 2015]: Sec. 8. (a) This section does not apply to the following:

22 (1) A person who is:

23 (A) a resident of Indiana; and

24 (B) an individual born before April 1, 1943.

25 (2) A person who is less than eighteen (18) years of age.

26 (3) A person who is legally blind.

27 (4) A person who is a resident patient of a state mental institution.

28 (5) A person who is:

29 (A) a resident of a health facility (as defined in
 30 IC 16-18-2-167) licensed in Indiana; and

31 (B) taking part in a supervised activity of the health facility.

32 (6) A person who:

33 (A) is a resident of Indiana; and

34 (B) has a developmental disability (as defined by
 35 IC 12-7-2-61).

36 (7) A person whose only participation in fishing is to assist an
 37 individual described in subdivision (3), (4), (5), or (6).

38 (8) A resident of Indiana who fishes during a free sport fishing
 39 day designated under IC 14-22-18.

40 (b) Every person must have a fishing license in the person's
 41 possession when fishing in:

42 (1) waters containing state owned fish;

- 1 (2) waters of the state; or
 2 (3) boundary waters of the state.
- 3 (c) Every person must have a valid **electronically generated**
 4 trout-salmon stamp in the person's possession to legally fish for or take
 5 trout or salmon in:
- 6 (1) waters containing state owned fish;
 7 (2) waters of the state; or
 8 (3) boundary waters of the state.
- 9 SECTION 14. IC 14-22-12-1, AS AMENDED BY P.L.289-2013,
 10 SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 11 JULY 1, 2015]: Sec. 1. (a) The department may issue the following
 12 licenses individually or in combination and, except as provided in
 13 section 1.5 of this chapter and subject to subsection (b), shall charge

 34 (\$12.75).
 35 (10) A nonresident license to hunt for five (5) consecutive days
 36 only, twenty-five dollars and seventy-five cents (\$25.75).
 37 (11) A resident or nonresident yearly **electronically generated**
 38 stamp to fish for trout and salmon, six dollars and seventy-five
 39 cents (\$6.75).
 40 (12) A resident yearly license to take a deer with a shotgun,
 41 muzzle loading gun, rifle, or handgun, thirteen dollars and
 42 seventy-five cents (\$13.75).

2 gun, thirteen dollars and seventy-five cents (\$13.75).
- 3 (14) A resident yearly license to take a deer with a bow and
4 arrow, thirteen dollars and seventy-five cents (\$13.75).
- 5 (15) A nonresident yearly license to take a deer with a shotgun,
6 muzzle loading gun, rifle, or handgun, one hundred twenty dollars

16 department under IC 4-22-2, five dollars (\$5).
- 17 (19) A nonresident license to take an extra deer by a means, in a
18 location, and under conditions established by rule adopted by the
19 department under IC 4-22-2, ten dollars (\$10).
- 20 (20) A resident yearly license to take a turkey, fourteen dollars
21 and seventy-five cents (\$14.75).
- 22 (21) A nonresident yearly license to take a turkey, one hundred
23 fourteen dollars and seventy-five cents (\$114.75).
- 24 (22) A resident license to take an extra turkey by a means, in a
25 location, and under conditions established by rule adopted by the
26 department under IC 4-22-2, fourteen dollars and seventy-five
27 cents (\$14.75).
- 28 (23) A nonresident license to take an extra turkey by a means, in
29 a location, and under conditions established by rule adopted by
30 the department under IC 4-22-2, one hundred fourteen dollars and
31 seventy-five cents (\$114.75).
- 32 (24) A resident youth yearly consolidated license to hunt, trap,
33 and fish, six dollars (\$6). This license is subject to the following:
- 34 (A) An applicant must be less than eighteen (18) years of age.
35 (B) The license is in lieu of the resident yearly license to hunt,
36 trap, and fish and all other yearly licenses, stamps, or permits
37 to hunt, trap, and fish for a specific species or by a specific
38 means.
- 39 (25) A nonresident youth yearly license to hunt, seventeen dollars
40 (\$17). The applicant must be less than eighteen (18) years of age.
- 41 (26) A nonresident youth yearly license to trap, seventeen dollars
42 (\$17). The applicant must be less than eighteen (18) years of age.



- 1 (27) A nonresident youth yearly license to take a turkey,
 2 twenty-five dollars (\$25). The applicant must be less than
 3 eighteen (18) years of age.
- 4 (28) A nonresident youth license to take an extra turkey by a
 5 means, in a location, and under conditions established by rule
 6 adopted by the department under IC 4-22-2, twenty-five dollars
 7 (\$25). The applicant must be less than eighteen (18) years of age.
- 8 (29) A nonresident youth yearly license to take a deer with a
 9 shotgun, muzzle loading gun, or rifle, twenty-four dollars (\$24).
 10 The applicant must be less than eighteen (18) years of age.
- 11 (30) A nonresident youth yearly license to take a deer with a
 12 muzzle loading gun, twenty-four dollars (\$24). The applicant
 13 must be less than eighteen (18) years of age.
- 14 (31) A nonresident youth yearly license to take a deer with a bow
 15 and arrow, twenty-four dollars (\$24). The applicant must be less
 16 than eighteen (18) years of age.
- 17 (32) A nonresident youth license to take an extra deer by a means,
 18 in a location, and under conditions established by rule adopted by
 19 the department under IC 4-22-2, twenty-four dollars (\$24). The

COMMITTEE REPORT

Mr. Speaker: Your Committee on Natural Resources, to which was referred House Bill 1452, has had the same under consideration and begs leave to report the same back to the House with the recommendation that said bill be amended as follows:

Page 4, between lines 25 and 26, begin a new paragraph and insert:

"SECTION 7. IC 14-19-1-1, AS AMENDED BY P.L.225-2005, SECTION 15, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 1. The department shall do the following:

- (1) Have the custody of and maintain the parks, preserves, forests, reservoirs, and memorials owned by the state.

Madam President: The Senate Committee on Natural Resources, to which was referred House Bill No. 1452, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, between the enacting clause and line 1, begin a new paragraph and insert:

"SECTION 1. IC 4-4-10.9-1.2, AS AMENDED BY P.L.233-2013, SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 1.2. SECTION 25. IC 14-28-5-9, AS AMENDED BY P.L.53-2008, SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 9. ~~The commission~~ **authority** shall authorize the making of a loan to a local unit under this chapter only when the following conditions exist:

- (1) An application for the loan has been submitted by the local unit ~~in a verified petition~~ to the **commission authority** in the manner and form that the **commission authority** directs. The



application must state the following:

- (A) The need for the flood control program and the need for money for instituting, accomplishing, and administering the program.
 - (B) A detailed description of the program.
 - (C) An engineering estimate of the cost of the proposed program acceptable to the **authority and the** commission.
 - (D) The amount of money considered to be needed.
 - (E) Other information that is requested by the **authority and the** commission.
- (2) There is a need, as determined by the commission, for the proposed flood control program for the purpose of protecting the health, safety, and general welfare of the inhabitants of the local unit.
- (3) The proposed flood control program has been approved by the commission, if before granting the approval, the commission determines the following:
- (A) That the program:
 - (i) is based upon sound engineering principles;
 - (ii) is in the interest of flood control; and
 - (iii) will accomplish the objectives of flood control.
 - (B) That for flood control programs involving the reconstruction or repair of existing flood control works that:
 - (i) in the judgment of the commission, constitutes an unreasonable obstruction or impediment to the proper discharge of flood flows; or
 - (ii) by virtue of their nature, location, or design, are subject to frequent damage or destruction;
 approval is limited to the work that is necessary to afford emergency protection against actual or threatened damage to life and property.
- (4) The local unit agrees and furnishes assurance, satisfactory to the commission, that the local unit will operate and maintain the flood control program, after completion, in a satisfactory manner.

SECTION 26. IC 14-28-5-14, AS AMENDED BY P.L.53-2008, SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2015]: Sec. 14. If a local unit fails to make a payment to the fund or any other payment required by this chapter or under IC 13-2-23 (before its repeal) or is in any way indebted to the fund for an amount incurred or accrued, the state may recover the amount through any of the following:

- (1) The state may, through the attorney general and on behalf of

(2) The auditor of state may, after a sixty (60) day written notice to the local unit, withhold the payment and distribution of state money that the defaulting local unit is entitled to receive under Indiana law.

(3) For a special taxing district, upon certification by the auditor of state after a sixty (60) day written notice to the special taxing district, the auditor of each county containing land within the special taxing district shall withhold collected tax money for the special taxing district and remit the withheld tax money to the auditor of state. The auditor of state shall make a payment to the fund in the name of the special taxing district. Upon elimination of the delinquency payment, the auditor of state shall certify the fact to the auditors of the counties involved and any additional withheld tax money shall be released to the special taxing district."
