1 A CONCURRENT RESOLUTION honoring the legacy of
2 the Hulman-George family and celebrating the incoming
3 leadership of Roger Penske and the Penske Corporation at the
4 Indianapolis Motor Speedway and INDYCAR.

5 *Whereas, Terre Haute native Tony Hulman purchased the*
6 *Indianapolis Motor Speedway in November 1945, beginning an*
7 *ambitious post-World War II restoration project that forever*
8 *altered Indiana's history and the trajectory of global*
9 *motorsports;*

10 *Whereas, Since that time, members of the Hulman-George*
11 *family have served as faithful stewards of the Racing Capital of*
12 *the World, "The Greatest Spectacle in Racing" and INDYCAR;*

13 *Whereas, 74 years of Hulman-George family leadership have*
14 *produced many historic firsts and milestones, including the*
15 *sold-out 100th Running of the Indianapolis 500, the inaugural*
16 *Brickyard 400 and the debut of life-saving SAFER Barrier*
17 *technology;*

18 *Whereas, The Indiana General Assembly recognizes a new*
19 *era of leadership at the Indianapolis Motor Speedway and*
20 *INDYCAR as all Hoosiers, young and old, mark the beginning*
21 *of a new decade;*

22 *Whereas, Roger Penske is an individual supremely prepared*
23 *to preserve and further the legacy of IMS, the Indianapolis 500*
24 *and the IndyCar Series;*

25 *Whereas, Roger Penske's track record in the world of*



1 professional motorsports is second to none, highlighted by
2 Team Penske's 18 Indianapolis 500 victories, 16 IndyCar Series
3 championships, two Daytona 500 victories, 545 major race
4 wins and 37 championships across professional racing
5 disciplines;

6 Whereas, Roger Penske is also the Founder and Chairman of
7 Penske Corporation, a global industry leader that employs
8 more than 64,000 individuals and manages more than \$32
9 billion in global revenue;

10 Whereas, Roger Penske's leadership principles include a
11 commitment to civic growth and philanthropy, highlighted by
12 his service as Chairman of Super Bowl XL and Penske
13 Corporation's support of many worthy charities and causes;

14 Whereas, Roger Penske is also a recipient of the highest
15 honor bestowed on an American civilian, the Presidential
16 Medal of Freedom, and many other prestigious awards and
17 honors, including induction in the Sports Broadcasting Hall of
18 Fame and NASCAR Hall of Fame; and

19 Whereas, Roger Penske's commitment to excellence, growth,
20 integrity and innovation in all his endeavors will now guide and
21 serve the Racing Capital of the World, North America's
22 pre-eminent open-wheel motorsports series and race fans
23 everywhere: Therefore,

24 Be it resolved by the House of Representatives
25 of the General Assembly of the State of Indiana,
26 the Senate concurring:

27 SECTION 1. That the Indiana General Assembly honors the
28 historic contributions of the Hulman-George family and
29 celebrates the incoming leadership of Roger Penske and the
30 Penske Corporation.

31 SECTION 2. That the Principal Clerk of the House of
32 Representatives transmit copies of this resolution to members
33 of the Hulman-George family and to Roger Penske, Founder
34 and Chairman of Penske Corporation.
