1           A CONCURRENT RESOLUTION urging the Indiana  
2 Department of Transportation to rename the State Road 46  
3 bridge over I-69 the "James A. Driver Memorial Bridge".

4           *Whereas, James A. Driver was born on December 27, 1982,*  
5 *in Upney, United Kingdom, to parents Kathleen and Alan*  
6 *Driver;*

7           *Whereas, James A. Driver graduated from Ivy Tech*  
8 *Community College and lived in Spencer, Indiana, with his wife*  
9 *Anna and their three children, Beau, Franklin, and LilyAnne;*

10           *Whereas, Driver wished to serve his community through*  
11 *public safety. In 2018, Driver was sworn into the Monroe*  
12 *County Indiana Sheriff's Office, Reserve Division upon*  
13 *graduating from the Sheriff's Office Reserve Academy and*  
14 *served as a reserve deputy;*

15           *Whereas, Driver was injured in the line of duty on March*  
16 *29th, 2021, after his patrol car collided with another vehicle on*  
17 *State Road 45 at the intersection of West Eller Road in*  
18 *Bloomington;*

19           *Whereas, Driver was transported to IU Health Bloomington*  
20 *Hospital, where he passed away from his injuries. He was 38*  
21 *years old. He is survived by his parents, his wife, his three*  
22 *children, as well as his sister Maria, niece Grace, and nephew*  
23 *Oliver; and*

24           *Whereas, It is fitting that the Indiana General Assembly*  
25 *recognize Reserve Deputy James A. Driver's service to the State*



1 *of Indiana and the people of Monroe County: Therefore,*

2 *Be it resolved by the House of Representatives*  
3 *of the General Assembly of the State of Indiana,*  
4 *the Senate concurring:*

5 SECTION 1. That the Indiana General Assembly urges the  
6 Indiana Department of Transportation to rename the State Road  
7 46 bridge over I-69 the "James A. Driver Memorial Bridge" in  
8 honor of his service.

9 SECTION 2. That the Principal Clerk of the House of  
10 Representatives shall transmit copies of this resolution to the  
11 Commissioner of the Indiana Department of Transportation.
