

## HOUSE RESOLUTION No. \_\_\_

A HOUSE RESOLUTION honoring Chief Greg Mance upon his retirement from the Town of Griffith Police Department.

Whereas, Chief Greg Mance retired from the Griffith Police
Department on January 10, 2025, after serving in public safety
for over 26 years;

Whereas, Before becoming chief of police, he served as a patrolman, corporal, patrol supervisor, and a detective from 2004 to 2013, and he was appointed commander of the Northwest Indiana Major Crimes Task Force. He spearheaded a multi-year landmark federal RICO investigation that led to the successful indictment and conviction of 24 offenders;

Whereas, Chief Mance led the department as chief of police from 2013 until 2025, and during his tenure he oversaw the

institution of new initiatives related to crime prevention, law 1 enforcement, and quality-of-life, including introducing the first 2 3 police social worker program in the state of Indiana to address complex community needs through proactive and 4 compassionate policing; 5 Whereas, He also oversaw the design and construction of a 6 new animal shelter for Griffith, helping create a state-of-the-art 7 facility that quadrupled capacity and serves to provide a 8 healthier and better living environment for animals in its care; 9 10 Whereas, Chief Mance cultivated a culture of collaboration and cooperation by working with Indiana 11 University Northwest's Center for Urban and Regional 12 Excellence to create the Prepare to Serve and Protect initiative 13 that promotes diversity in the hiring process, by fostering 14 communication between multiple counties as President of the 15 District 1 Law Enforcement Council, and by securing funding 16 for a dedicated Northern Indiana Law Enforcement Academy 17 (NILEA) site as President of the NILEA to enhance training 18 19 capabilities for law enforcement professionals across northern Indiana; 20 21 Whereas, Chief Mance has consistently demonstrated a commitment to department goals, mentoring colleagues, and 22 ensuring community safety; and 23 Whereas, Chief Greg Mance's steadfast leadership, 24 innovative strategies, and dedication to public service left a 25 lasting impact on the Griffith Police Department and the 26 broader law enforcement community. His career stands as a 27 testament to his commitment to safety, justice, and community 28 well-being: Therefore, 29 30 *Be it resolved by the House of Representatives of the* General Assembly of the State of Indiana: 31 SECTION 1. That the Indiana House of Representatives 32 honors Chief Greg Mance upon his retirement from the Town 33 of Griffith Police Department. 34 SECTION 2.
