1 A HOUSE RESOLUTION congratulating and honoring
2 Mr. Adrian Huizar, a top youth volunteer of Indiana for 2019.

3 *Whereas, The annual Prudential Spirit of Community*
4 *Awards recognized Mr. Adrian Huizar of Michigan City as a*
5 *State Honoree and a top youth volunteer in Indiana for 2019;*

6 *Whereas, 29,000 young people across the country*
7 *participated in the 2019 program;*

8 *Whereas, Mr. Huizar, an eighth-grader at Queen of All*
9 *Saints Catholic School, earned this award by giving generously*
10 *of his time and energy to start, build, and maintain a tutoring*
11 *program at his school;*

12 *Whereas, Mr. Huizar received approval from his school and*
13 *interested parents in 2017, and he built a program that offers*

1 *children in first through sixth grades tutoring lessons for 45*
2 *minutes a day, four days a week;*

3 *Whereas, Mr. Huizar enlisted the support of National Junior*
4 *Honor Society members and found adults willing to be present*
5 *during tutoring sessions;*

6 *Whereas, Mr. Huizar is responsible for all scheduling and*
7 *attendance, and provides the tutors with worksheets to use*
8 *during their lessons;*

9 *Whereas, More than 60 students, tutors, and supervisors*
10 *have been involved in the program since its creation;*

11 *Whereas, The Prudential Spirit of Community Awards*
12 *program was created in 1995 by Prudential Financial, in*
13 *partnership with the National Association of Secondary Schools*
14 *Principals, and is designed to emphasize the importance of*
15 *volunteerism and service to the community;*

16 *Whereas, Mr. Huizar represents the best of America's youth,*
17 *and is a role model to his peers and fellow Hoosiers;*

18 *Whereas, Mr. Huizar will receive a \$1,000 award, an*
19 *engraved silver medallion, and a trip to Washington, D.C., as*
20 *one of two State Honorees from Indiana; and*

21 *Whereas, Mr. Huizar will be considered for one of 10*
22 *national awards that would provide him with an additional*
23 *\$5,000 award and a \$5,000 grant from the Prudential*
24 *Foundation to a charitable organization of his choice:*

26 *Be it resolved by the House of Representatives of the*
27 *General Assembly of the State of Indiana:*

28 SECTION 1. That the House of Representatives
29 congratulates Mr. Adrian Huizar as a 2019 top youth volunteer
30 and for being named a State Honoree by the Prudential Spirit of
31 Community Awards.
