

SENATE BILL No. 14

DIGEST OF INTRODUCED BILL

Citations Affected: IC 9-29-17-10.

Synopsis: License fees for wholesale auto dealers. Provides that the fee for a wholesale automotive dealer's license after 2014 is \$125. (The current fee for a wholesale automotive dealer's license is \$20.)

Effective: July 1, 2014.

SENATE BILL No. 14

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 9-29-17-10, AS ADDED BY P.L.92-2013,
2 SECTION 74, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2014]: Sec. 10. **(a)** The fee for a factory representative, a
4 distributor representative, a wholesale dealer, a transfer dealer, a
5 converter manufacturer, or an automotive mobility dealer under
6 IC 9-32-11-1 is twenty dollars (\$20). The fee for an automotive
7 mobility dealer who:
8 (1) buys or sells vehicles, or both;
9 (2) sells, installs, or services, offers to sell, install, or service, or
10 solicits or advertises the sale, installation, or servicing of
11 equipment or modifications specifically designed to facilitate use
12 or operation of a vehicle by an individual who is disabled or aged;
13 or
14 (3) performs acts described in both subdivisions (1) and (2);
15 is twenty dollars (\$20). The fees collected shall be deposited as set
16 forth in IC 9-32-7-3. **For licenses effective after December 31, 2014,**



1 **the fee set forth in subsection (b) applies for a wholesale dealer.**
2 **(b) For licenses effective after December 31, 2014, the fee for a**
3 **wholesale dealer under IC 9-32-11-1 is one hundred twenty-five**
4 **dollars (\$125). The fees collected shall be deposited as set forth in**
5 **IC 9-32-7-3.**
