**Synopsis:** Marion circuit court magistrate. Allows the judge of the Marion circuit court to appoint one full-time magistrate to serve the circuit court. (The introduced version of this bill was prepared by the interim study committee on courts and the judiciary.)

Second Regular Session 119th General Assembly (2016)

PRINTING CODE. Amendments: Whenever an existing statute (or a section of the Indiana Constitution) is being amended, the text of the existing provision will appear in this style type, additions will appear in **this style type**, and deletions will appear in ~~this style type~~.

Additions: Whenever a new statutory provision is being enacted (or a new constitutional provision adopted), the text of the new provision will appear in **this style type**. Also, the word **NEW** will appear in that style type in the introductory clause of each SECTION that adds a new provision to the Indiana Code or the Indiana Constitution.

Conflict reconciliation: Text in a statute in *this style type* or ~~this style type~~ reconciles conflicts between statutes enacted by the 2015 Regular Session of the General Assembly.

A BILL FOR AN ACT to amend the Indiana Code concerning courts and court officers.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 33-33-49-2 IS AMENDED TO READ AS  
2 FOLLOWS [EFFECTIVE JULY 1, 2016]: Sec. 2. **(a)** Marion County  
3 constitutes the nineteenth judicial circuit.  
4 **(b) The judge of the Marion circuit court may appoint one (1)**  
5 **full-time magistrate under IC 33-23-5 to serve the circuit court.**  
6 **The magistrate continues in office until removed by the judge.**
