SENATE BILL No. 27

DIGEST OF SB 27 (Updated January 29, 2020 4:19 pm - DI 133)

Citations Affected: IC 4-23; noncode.

Synopsis: Native American Indian affairs commission. Changes the membership requirements for members of the Native American Indian affairs commission as follows: (1) Specifies that eight, rather than six, members must be Native American Indians from different geographic regions of Indiana. (2) Removes the requirement that two members must be Native American Indians who have knowledge in Native American traditions and spiritual issues. (3) Replaces the commissioner of the commission for higher education or the commissioner's designee as an ex officio member with the director of the department of child services or the director's designee. (4) Provides that not more than two members of the commission may represent the same tribe or organization. (Current law limits a particular tribe or organization to one member.)

Effective: July 1, 2020.

A BILL FOR AN ACT to amend the Indiana Code concerning state offices and administration.

Be it enacted by the General Assembly of the State of Indiana:

- 27 **affairs commission established by IC 4-23-32-3.**
- 28 **(b) An individual who:**
- 29 **(1) serves as a member of the commission on June 30, 2020;**
- 30 **and**
- 31 **(2) is disqualified for further service on the commission by**
- 32 **IC 4-23-32-4, as amended by this act;**
- 33 **may continue to serve on the commission after June 30, 2020, until**
- 34 **a qualified individual is appointed under IC 4-23-32-4, as amended**
- 35 **by this act.**
- 36 **(c) This SECTION expires June 30, 2021.**
