DIGEST OF SB 58 (Updated February 11, 2014 10:49 am - DI 84)

**Citations Affected:** IC 10-17; IC 10-18; IC 21-41.

**Synopsis:** Local appropriations for Memorial Day expenses. Removes an outdated list of veterans organizations from the statute authorizing counties, townships, cities, and towns to appropriate money to veterans organizations to defray the expenses of Memorial Day. Makes conforming changes. (The introduced version of this bill was prepared by the commission on military and veterans affairs.)

**Effective:** July 1, 2014.

## ENGROSSED SENATE BILL No. 58

A BILL FOR AN ACT to amend the Indiana Code concerning military and veterans.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 10-17-13-5, AS AMENDED BY P.L.113-2010,  
2 SECTION 83, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2014]: Sec. 5. The commission consists of the following  
4 members:  
5 (1) Seven (7) members appointed by the governor. The governor  
6 shall consider the following when making appointments under  
7 this subdivision:  
8 (A) Membership ~~in:~~ **in**  
9 (i) a veterans association established under IC 10-18-6. ~~or~~  
10 (ii) a ~~veterans organization listed in IC 10-18-8-1.~~  
11 (B) Service in the armed forces of the United States (as  
12 defined in IC 5-9-4-3) or the national guard (as defined in  
13 IC 5-9-4-4).  
14 (C) Experience in education, including higher education,  
15 vocational education, or adult education.  
16 (D) Experience in investment banking or finance.

20 (c) In a county in which there is a county Memorial Day society,  
 21 county veterans' council, or any other county Memorial Day association  
 22 not listed in subsection (a) that coordinates the Memorial Day  
 23 celebration for the county instead of one (1) of the organizations listed  
 24 in subsection (a), the county council may annually appropriate to one  
 25 (1) society, council, or association, instead of the appropriations to the  
 26 various organizations listed in subsection (a), a sum to aid in defraying  
 27 the expenses of the Memorial Day celebration.

28 (d) An appropriation under subsection (b) or (c) is in addition to any  
 29 appropriation under subsection (a).

30 SECTION 3. IC 21-41-10-10, AS ADDED BY SEA 24-2014,  
 31 SECTION 98, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 32 JULY 1, 2014]: Sec. 10. (a) Each state educational institution shall  
 33 designate a program coordinator.

34 (b) The duties of the coordinator include the following:

- 35 (1) Develop programs to create a positive educational  
 36 environment for veteran students while the veteran student is  
 37 enrolled at the state educational institution.  
 38 (2) Develop training programs for the state educational  
 39 institution's personnel relating to:  
 40 (A) issues associated with identifying and assisting veteran  
 41 students with posttraumatic stress disorder;  
 42 (B) veteran benefits; and



- 1 (C) any issue that the coordinator determines will educate a  
2 state educational institution's faculty or staff of the special  
3 needs of veteran students.
- 4 (3) Make recommendations to the commission for higher  
5 education established under IC 21-18-2 concerning ways to  
6 improve the education of veteran students.
- 7 (4) Coordinate access to stress management, counseling  
8 programs, and other resources available to a veteran student at the  
9 state educational institution.
- 10 (5) Coordinate with the Indiana department of veterans' affairs  
11 established by IC 10-17-1-2 to educate veteran students about  
12 state benefits available to Indiana veterans.
- 13 (6) Coordinate with the United States Department of Veterans  
14 Affairs to educate veteran students about federal benefits  
15 available to veterans.
- 16 (7) Coordinate with the adjutant general or the adjutant general's  
17 designee to educate veteran students about benefits and programs  
18 available to veteran students who served or are currently serving  
19 in the national guard.
- 20 (8) Coordinate activities, seminars, and programs for veteran  
21 students presented by a veterans organization. ~~listed in~~

- 23 (9) Coordinate campus activities and social events designed for  
24 veteran students.
- 25 (10) Develop programs to assist a veteran student to locate  
26 employment.
- 27 (11) Develop internship programs designed specifically for

- 29 (12) Develop an Internet web site to provide veteran students  
30 access to veteran resources.
