Citations Affected: Noncode.

Synopsis: Pharmacist care study. Urges the legislative council to assign the topic of coverage for pharmacist care to an interim study committee during the 2019 interim of the general assembly.

Effective: July 1, 2019.

Madam President: The Senate Committee on Insurance and Financial Institutions, to which was referred Senate Bill No. 108, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Delete the title and insert the following:

A BILL FOR AN ACT concerning insurance.

Page 1, line 1, delete "IC 27-8-6-8 IS ADDED TO THE INDIANA CODE".

Page 1, line 2, delete "AS A NEW SECTION TO READ AS FOLLOWS".

Page 1, line 3, delete ": Sec. 8.".

Page 1, line 3, delete "section," and insert "SECTION,".

Page 1, delete lines 5 through 17, begin a new paragraph and insert:

"(b) The legislative council is urged to assign to an interim study committee for study during the 2019 interim of the general assembly the topic of coverage for pharmacist care.

(c) If the legislative council assigns the topic described in subsection (b), the interim study committee shall study and report to the legislative council, in an electronic format under IC 5-14-6, not later than November 1, 2019, any recommendations concerning the following:

(1) Creation of an "advanced practice pharmacist".

(2) The qualifications and functions of an "advanced practice pharmacist".

(3) Inclusion of pharmacists and "advanced practice pharmacists" as providers in networks of insurers that issue policies of accident and sickness insurance.

(d) This SECTION expires December 31, 2019."
