## DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 9-18; IC 9-29-5.

**Synopsis:** Environmental license plate fees. Provides that after December 31, 2015, the fee for registration of a vehicle for issuance of an environmental license plate may not include a supplemental fee of \$10, used for the bureau of motor vehicles commission fund, the crossroads 2000 fund, and the integrated public safety communications fund. Makes corresponding changes.

A BILL FOR AN ACT to amend the Indiana Code concerning motor vehicles and to make an appropriation.

*Be it enacted by the General Assembly of the State of Indiana:*

1 SECTION 1. IC 9-18-17-5, AS ADDED BY P.L.216-2014,  
2 SECTION 41, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2015]: Sec. 5. A vehicle for a which a license plate is issued  
4 under section 1 of this chapter is exempt from the following fees:  
5 (1) The applicable annual registration fee for the vehicle under  
6 IC 9-29-5.  
7 (2) The annual supplemental fee under IC 9-29-5-38(a) **before**  
8 **January 1, 2016, or IC 9-29-5-38.3(b) after December 31,**  
9 **2015.**  
10 (3) A special group recognition license plate fee under  
11 IC 9-18-25-17.5 or IC 9-18-25-17.7.  
12 However, the vehicle is subject to a service charge under  
13 IC 9-29-5-38(c) **before January 1, 2016, or IC 9-29-5-38.3(e) after**  
14 **December 31, 2015.**  
15 SECTION 2. IC 9-18-25-17.5, AS AMENDED BY P.L.216-2014,  
16 SECTION 45, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE



1 JULY 1, 2015]; Sec. 17.5. (a) This section applies to a special group if  
2 at least five thousand (5,000) of the special group's license plates are  
3 issued under this chapter during one (1) calendar year beginning after  
4 December 31, 2004.

5 (b) ~~Notwithstanding section 2 of this chapter~~, The representatives  
6 of the special group may petition the bureau to design a distinctive  
7 license plate that identifies a vehicle as being registered to a person  
8 who is a member of the special group.

9 (c) The design of the special group license plate must include a  
10 basic design for the special group recognition license plate with  
11 consecutive numerals or letters, or both, to properly identify the  
12 vehicle.

13 (d) A special group license plate must be treated with special  
14 reflective material designed to increase the visibility and legibility of  
15 the special group license plate.

16 (e) Beginning with the calendar year following the year in which the  
17 representatives petition the bureau under subsection (b), the bureau  
18 shall issue the special group's license plate to a person who is eligible  
19 to register a vehicle under this title who:

20 (1) completes an application for the license plate; and

21 (2) pays the following fees:

22 (A) The appropriate fee under:

23 (i) IC 9-29-5-38(a) **before January 1, 2016; or**

24 (ii) **IC 9-29-5-38.3(b) or IC 9-29-5-38.3(c) after**  
25 **December 31, 2015.**

26 (B) An annual special group recognition license plate fee of  
27 twenty-five dollars (\$25).

28 (f) The annual fee referred to in subsection (e)(2)(B) shall be  
29 collected by the bureau and deposited in a trust fund for the special  
30 group established under subsection (g). However, the bureau shall  
31 retain two dollars (\$2) for each license plate issued until the cost of  
32 designing and issuing the special group license plate is recovered by  
33 the bureau.

34 (g) The treasurer of state shall establish a trust fund for each special  
35 group for which the bureau collects fees under this section.

36 (h) The treasurer of state shall invest the money in the fund not  
37 currently needed to meet the obligations of the fund in the same  
38 manner as other public funds are invested. Interest that accrues from  
39 these investments shall be deposited in the fund. Money in the fund is  
40 continuously appropriated for the purposes of this section. Money in  
41 the fund at the end of a state fiscal year does not revert to the state  
42 general fund.



1 (i) The commissioner shall administer the fund. Expenses of  
2 administering the fund shall be paid from money in the fund.

3 (j) On June 30 of each year, the commissioner shall distribute the  
4 money from the fund to the special group for which the bureau has  
5 collected fees under this section.

6 (k) The bureau may not disclose information that identifies the  
7 persons to whom special group license plates have been issued under  
8 this section.

17 the following fees:

18 (1) The appropriate fee under:

19 (A) IC 9-29-5-38(a) before January 1, 2016; or

20 (B) IC 9-29-5-38.3(b) or IC 9-29-5-38.3(c) after December  
21 31, 2015.

22 (2) An annual fee of twenty-five dollars (\$25) or less, as requested  
23 by the special group.

24 (c) The annual fee referred to in subsection (b)(2) shall be collected  
25 by the bureau and deposited in a trust fund for the special group  
26 established under subsection (d).

27 (d) The treasurer of state shall establish a trust fund for each special  
28 group for which the bureau collects fees under this section.

29 (e) The treasurer of state shall invest the money in the fund not  
30 currently needed to meet the obligations of the fund in the same  
31 manner as other public funds are invested. Interest that accrues from  
32 these investments shall be deposited in the fund. Money in the fund is  
33 continuously appropriated for the purposes of this section. Money in  
34 the fund at the end of a state fiscal year does not revert to the state  
35 general fund.

36 (f) The commissioner shall administer the fund. Expenses of  
37 administering the fund shall be paid from money in the fund.

38 (g) Before June 30 of each year, the commissioner shall distribute  
39 the money from the fund to the special group for which the bureau has  
40 collected fees under this section.

41 (h) Subject to section 18 of this chapter, the bureau may not disclose  
42 information that identifies the persons to whom special group license

3 (1) representatives of a special group have collected an annual fee  
4 as set forth in subsection (a) from purchasers of the special group  
5 recognition license plates that was paid directly to the special  
6 group; and

7 (2) the representatives of the special group request the bureau to  
8 collect the annual fee on behalf of the special group as set forth in  
9 subsection (a);

10 representatives of the special group may request the bureau to change  
11 the method of collection of the annual fee for the following calendar  
12 year. The representatives of the special group must make a request  
13 under this subsection by July 1 of the year preceding the year for which  
14 the change has been requested. The group may request only one (1)  
15 change in the method of collection in a plate cycle.

16 (j) If:

17 (1) the bureau collects an annual fee as set forth in subsection (a)  
18 on behalf of a special group; and

19 (2) representatives of the special group request the bureau to  
20 cease collection of the annual fee as set forth in subsection (a) on  
21 behalf of the special group as the annual fee will be paid directly  
22 to the special group by purchasers of the special group  
23 recognition license plates;

24 representatives of the special group may request the bureau to change  
25 the method of collection of the annual fee for the following calendar  
26 year. The representatives of the special group must make a request  
27 under this subsection by July 1 of the year preceding the year for which  
28 the change has been requested. The group may request only one (1)  
29 change in the method of collection in a plate cycle.
