## **SENATE BILL No. 112**

DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-18-2-328.2; IC 16-32-3.5.

**Synopsis:** Service animals. Amends the definition of "service animal" to include a service animal in training for purposes of provisions governing service animals on the premises of a public accommodation. Provides that misrepresenting an animal as a service animal to obtain a right or privilege in a public accommodation is a Class C infraction.

Effective: July 1, 2025.

28	animal in any public accommodation to obtain a right or privilege
29	that is available to a person who qualifies to possess a service
30	animal under state or federal law, knowing that the person is not
31	entitled to those rights or privileges, commits misrepresentation of
32	a service animal, a Class C infraction.
