DIGEST OF SB 145 (Updated January 7, 2015 6:03 pm - ck)

Citations Affected: IC 6-3.1; noncode.

Synopsis: Indiana EITC. Increases the amount of the Indiana earned income tax credit from 9% to 10% of the federal earned income tax credit.

Effective: January 1, 2015 (retroactive).

SENATE BILL No. 145

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 6-3.1-21-6, AS AMENDED BY P.L.229-2011,
2 SECTION 87, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JANUARY 1, 2015 (RETROACTIVE)]: Sec. 6. (a) Except as provided
4 by subsection (b), an individual who is eligible for an earned income
5 tax credit under Section 32 of the Internal Revenue Code, as it existed
6 before being amended by the Tax Relief, Unemployment Insurance
7 Reauthorization, and Job Creation Act of 2010 (P.L. 111-312), is
8 eligible for a credit under this chapter equal to ~~nine percent (9%)~~ **ten**
9 **percent (10%)** of the amount of the federal earned income tax credit
10 that the individual:
11 (1) is eligible to receive in the taxable year; and
12 (2) claimed for the taxable year;
13 under Section 32 of the Internal Revenue Code as it existed before
14 being amended by the Tax Relief, Unemployment Insurance
15 Reauthorization, and Job Creation Act of 2010 (P.L. 111-312).
16 (b) In the case of a nonresident taxpayer or a resident taxpayer

- 1 residing in Indiana for a period of less than the taxpayer's entire taxable
2 year, the amount of the credit is equal to the product of:
- 3 (1) the amount determined under subsection (a); multiplied by
 - 4 (2) the quotient of the taxpayer's income taxable in Indiana
 - 5 divided by the taxpayer's total income.
- 6 (c) If the credit amount exceeds the taxpayer's adjusted gross
7 income tax liability for the taxable year, the excess, less any advance
8 payments of the credit made by the taxpayer's employer under
9 IC 6-3-4-8 that reduce the excess, shall be refunded to the taxpayer.
- 10 SECTION 2. [EFFECTIVE JANUARY 1, 2015 (RETROACTIVE)]
- 11 **(a) IC 6-3.1-21-6, as amended by this act, applies only to taxable**
12 **years beginning after December 31, 2014.**
- 13 **(b) This SECTION expires January 1, 2018.**
- 14 SECTION 3. An emergency is declared for this act.
