DIGEST OF SB 154 (Updated January 12, 2016 10:08 am - DI 109)

Citations Affected: IC 10-16.

Synopsis: Indiana national guardsmen funeral allowance. Increases from \$4,000 to \$8,800 the funeral allowance for a member of the Indiana national guard who dies in the active service of the state.

Effective: July 1, 2016.

SENATE BILL No. 154

A BILL FOR AN ACT to amend the Indiana Code concerning military and veterans.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 10-16-7-19 IS AMENDED TO READ AS
2 FOLLOWS [EFFECTIVE JULY 1, 2016]: Sec. 19. (a) A member of
3 the Indiana national guard who is wounded or disabled or was disabled
4 in the service of the state including service related to:
5 (1) a riot;
6 (2) a tumult;
7 (3) a breach of the peace;
8 (4) a resistance to process;
9 (5) an invasion;
10 (6) a public disaster;
11 (7) the aid of civil authority; or
12 (8) a lawfully ordered parade, drill, encampment, or inspection;
13 within ten (10) years preceding the member's application for a pension
14 under this chapter shall, upon proof of the disability, be placed on the
15 roll of invalid pensioners of the state and shall receive out of money in
16 the state treasury not otherwise appropriated, upon the audit of the
17 adjutant general and approval of the governor, the same pension or

1 reward that a person under similar circumstances would receive from
2 the United States. In case of a wound, an injury, or a disease that results
3 in death, the surviving spouse, dependent children, or dependent parent
4 of the member of the Indiana national guard shall receive the pension
5 and reward dating from the time of receiving the injuries on account of
6 which the pension or reward is allowed. An officer or enlisted person
7 is not entitled while in active service to apply for or receive a pension.

8 (b) If a member of the Indiana national guard dies in the active
9 service of the state, the member's reasonable funeral expenses, not
10 exceeding ~~four thousand~~ **eight thousand eight hundred** dollars
11 ~~(\$4,000)~~, **(\$8,800)**, shall be paid by the state in the manner as the
12 governor directs.

13 (c) This section does not make applicable any provision of the
14 national service life insurance law of the United States, and the pension
15 or reward granted under this section shall be that provided for by the
16 pension laws of the United States in substance, without regard to form.
