

SENATE BILL No. 154

DIGEST OF INTRODUCED BILL

Citations Affected: IC 16-38-4.

Synopsis: Autism reporting. Requires a diagnosis of autism at any age to be reported to the birth problems registry. (Current law provides for the reporting of an autism diagnosis made before a child's fifth birthday.)

Effective: July 1, 2014.

SENATE BILL No. 154

A BILL FOR AN ACT to amend the Indiana Code concerning health.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 16-38-4-1, AS AMENDED BY P.L.232-2013,
2 SECTION 6, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2014]: Sec. 1. As used in this chapter, "birth problems" means
4 one (1) or more of the following conditions:
5 (1) A structural deformation.
6 (2) A developmental malformation.
7 (3) A genetic, inherited, or biochemical disease.
8 (4) A condition of a chronic nature, including central nervous
9 system hemorrhage or infection of the central nervous system,
10 that may result in a need for long term health care.
11 (5) An autism spectrum disorder that is recognized in ~~a child~~
12 ~~before the child becomes five~~ (5) **an individual at any years of**
13 **age.**
14 (6) A fetal alcohol spectrum disorder that is recognized before a
15 child becomes five (5) years of age.
16 (7) Any other severe disability that is:



- 1 (A) designated in a rule adopted by the state department; and
 2 (B) recognized in a child after birth and before the child
 3 becomes three (3) years of age.
 4 (8) Complications resulting from a home delivery. As used in this
 5 subdivision, "home" includes the delivery of a viable fetus at a
 6 home or other non-health care facility.
- 7 SECTION 2. IC 16-38-4-8, AS AMENDED BY P.L.188-2013,
 8 SECTION 20, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
 9 JULY 1, 2014]: Sec. 8. (a) The state department shall establish a birth
 10 problems registry for the purpose of recording all cases of birth
 11 problems that occur in Indiana residents and compiling necessary and
 12 appropriate information concerning those cases, as determined by the
 13 state department, in order to:
- 14 (1) conduct epidemiologic and environmental studies and to apply
 15 appropriate preventive and control measures;
 16 (2) inform the parents of children with birth problems:
 17 (A) at the time of discharge from the hospital; or
 18 (B) if a birth problem is diagnosed during a physician or
 19 hospital visit that occurs before the child is:
 20 (i) except as provided in item (ii), three (3) years of age at
 21 the time of diagnosis; or
 22 (ii) five (5) years of age at the time of diagnosis if the
 23 disorder is ~~an autism spectrum disorder or~~ a fetal alcohol
 24 spectrum disorder;
 25 about physicians, care facilities, and appropriate community
 26 resources, including local step ahead agencies and the infants and
 27 toddlers with disabilities program (IC 12-12.7-2); ~~or~~
 28 **(3) inform:**
 29 **(A) the individual with problems at any age; or**
 30 **(B) the individual's parent;**
 31 **at the time of diagnosis, if the individual's disorder is an**
 32 **autism spectrum disorder, about physicians, care facilities,**
 33 **and appropriate community resources, including local step**
 34 **ahead agencies and the infants and toddlers with disabilities**
 35 **program (IC 12-12.7-2); or**
 36 ~~(3)~~ **(4) inform citizens regarding programs designed to prevent or**
 37 **reduce birth problems.**
- 38 (b) The state department shall record in the birth problems registry:
 39 (1) all data concerning birth problems of children that are
 40 provided from the certificate of live birth; and
 41 (2) any additional information that may be provided by an
 42 individual or entity described in section 7(a)(2) of this chapter



1 concerning a birth problem that is:

2 (A) designated in a rule adopted by the state department; and

3 (B) recognized:

4 (i) after the child is discharged from the hospital as a
5 newborn;

6 (ii) before the child is five (5) years of age if the child is
7 diagnosed with ~~an autism spectrum disorder~~ or a fetal
8 alcohol spectrum disorder; ~~and~~

9 (iii) before the child is three (3) years of age for any
10 diagnosis not specified in item (ii); **and**

11 **(iv) at any age if the individual is diagnosed with an**
12 **autism spectrum disorder.**

13 (c) The state department shall:

14 (1) provide a physician and a local health department with
15 necessary forms for reporting under this chapter; and

16 (2) report in an electronic format under IC 5-14-6 to the
17 legislative council any birth problem trends that are identified
18 through the data collected under this chapter.

19 SECTION 3. IC 16-38-4-9, AS AMENDED BY P.L.232-2013,
20 SECTION 8, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
21 JULY 1, 2014]: Sec. 9. (a) Certified nurse midwives, certified direct
22 entry midwives, and individuals and entities described in section
23 7(a)(2) of this chapter shall report each confirmed case of a birth
24 problem that is recognized at the time of birth to the registry not later
25 than sixty (60) days after the birth. An individual or entity described in
26 section 7(a)(2) of this chapter who recognizes a birth problem in:

27 **(1) a child after birth but before the child is five (5) years of age**
28 **if the child is diagnosed with a disorder other than an autism**
29 **spectrum disorder; and**

30 **(2) an individual at any age if the individual is diagnosed with**
31 **an autism spectrum disorder;**

32 shall report the birth problem to the registry not later than sixty (60)
33 days after recognizing the birth problem. Information may be provided
34 to amend or clarify an earlier reported case.

35 (b) A person required to report information to the registry under this
36 section may use, when completing reports required by this chapter,
37 information submitted to any other public or private registry or required
38 to be filed with federal, state, or local agencies. However, the state
39 department may require additional, definitive information.

40 (c) Exchange of information between state department registries is
41 authorized. The state department may use information from another
42 registry administered by the state department. Information used from



1 other registries remains subject to the confidentiality restrictions on the
2 other registries.
