## DIGEST OF INTRODUCED BILL

Citations Affected: IC 22-4.1-27.

**Synopsis:** Indiana youth service program. Establishes the Indiana youth service program (program) to provide high school graduates with the opportunity to learn various skills and participate in nine months of service at host sites throughout Indiana. Establishes the Indiana youth service program fund (fund). Provides that the department of workforce development shall administer the program and the fund.

Effective: July 1, 2019.
