SENATE BILL No. 170

DIGEST OF SB 170 (Updated January 22, 2019 2:12 pm - DI 104)

Citations Affected: IC 31-25.

Synopsis: Child fatality report information. Specifies that the report concerning child fatalities in Indiana must be completed before September 1 of each year for the preceding calendar year and include information concerning whether the death occurred: (1) while the child was placed in foster care; or (2) after the child, who was once placed in foster care, was returned to a natural parent.

Effective: July 1, 2019.

SENATE BILL No. 170

A BILL FOR AN ACT to amend the Indiana Code concerning family law and juvenile law.

Be it enacted by the General Assembly of the State of Indiana:

- 1 SECTION 1. IC 31-25-2-24, AS ADDED BY P.L.119-2013,
2 SECTION 9, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3 JULY 1, 2019]: Sec. 24. **(a) Before September 1 of each year**, the
4 department shall annually prepare a report concerning all child
5 fatalities in Indiana that are the result of child abuse or neglect **in the**
6 **preceding calendar year**. The report must include the following
7 information:
8 (1) A summary of the information gathered concerning child
9 fatalities resulting from abuse or neglect.
10 (2) Demographic information regarding victims, perpetrators, and
11 households involved in child fatalities resulting from abuse or
12 neglect.
13 (3) An analysis of the primary risk factors involved in child
14 fatalities resulting from abuse or neglect.
15 (4) A summary of the most frequent causes of child fatalities
16 resulting from abuse or neglect.
17 (5) A description of the manner in which the information was

2 The department shall post the report prepared under this section on the
3 department's Internet web site.
4 **(b) As part of the summary of information described in**
5 **subsection (a)(1), the report must include whether the death**
6 **occurred in either of the following settings:**
7 **(1) While the child was placed in foster care.**
8 **(2) After the child, who was once placed in foster care, was**
9 **returned to a natural parent.**
