# **SENATE BILL No. 172**

#### DIGEST OF INTRODUCED BILL

**Citations Affected:** IC 16-18-2-122; IC 16-19-3-32; IC 25-8.5-2.

**Synopsis:** Behavior analysis services. Adds one member to the behavior analyst committee (committee). Requires the state department of health to inspect at least one time per year each facility where a licensed behavior analyst practices behavior analysis. Requires the committee to recommend proposed rules to the medical licensing board of Indiana concerning standards for the annual inspections.

Effective: July 1, 2022.

A BILL FOR AN ACT to amend the Indiana Code concerning health.

13	1, 2022]: Sec. 32. (a) As used in this section, "facility" means a
14	facility where a licensed behavior analyst conducts the practice of
15	behavior analysis, as defined in IC 25-8.5-1-4.
16	(b) The state department shall inspect each facility at least one
17	(1) time per calendar year and may conduct a complaint inspection

9	(2) One (1) consumer member.
10	(3) One (1) physician member.
11	(4) One (1) member employed by the office of the secretary of
12	family and social services.
13	(c) A member appointed to the committee serves a term under
14	IC 25-1-6.5.
15	SECTION 4. IC 25-8.5-2-6, AS ADDED BY P.L.212-2021,
16	SECTION 11, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
17	JULY 1, 2022]: Sec. 6. (a) The committee shall recommend proposed
18	rules to the board establishing standards for the following:
19	(1) The competent practice of behavior analysis.
20	(2) The renewal of licenses issued under this chapter.
21	(3) Continuing education requirements for an individual seeking
22	renewal of licensure as a behavior analyst or assistant behavior
23	analyst.
24	(4) The approval of continuing education providers, programs,
25	courses, fees, and proof of course completion.
26	(5) The annual inspection of a facility that provides behavior
27	analysis services, as required under IC 16-19-3-32.
28	The board, after considering the committee's recommendations under
29	this subsection, shall adopt rules under IC 4-22-2 concerning the
30	standards described in this subsection.
31	(b) The committee shall recommend, and the board, after
32	considering the committee's recommendations, shall establish fees
33	under IC 25-1-8-2.
34	(c) The committee shall do the following:
35	(1) Consider the qualifications of individuals who apply for a
36	license under this chapter.
37	(2) Subject to IC 25-1-8-6, renew licenses under this article.

(3) Conduct proceedings under IC 25-1-9.
