DIGEST OF SB 172 (Updated February 1, 2023 3:13 pm - DI 139)

**Citations Affected:** IC 4-32.3; IC 4-36.

**Synopsis:** Maximum price of a pull tab in charity gaming. Increases the maximum price of a charity gaming ticket for a pull tab, punchboard, or tip board game from \$1 to \$5. Increases the maximum selling price for one ticket for type II gaming from \$1 to \$5.

**Effective:** July 1, 2023.

## SENATE BILL No. 172

A BILL FOR AN ACT to amend the Indiana Code concerning gaming.

*Be it enacted by the General Assembly of the State of Indiana:*

- 1 SECTION 1. IC 4-32.3-5-16, AS AMENDED BY P.L.145-2021,  
2 SECTION 10, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
3 JULY 1, 2023]: Sec. 16. (a) The total prizes awarded for one (1) pull  
4 tab, punchboard, or tip board game may not exceed fifteen thousand  
5 dollars (\$15,000).  
6 (b) A single prize awarded:  
7 (1) for one (1) winning ticket in a pull tab, punchboard, or tip  
8 board game may not exceed five hundred ninety-nine dollars  
9 (\$599);  
10 (2) in a game using a seal card may not exceed one thousand  
11 dollars (\$1,000); and  
12 (3) in a progressive or carryover pull tab game may not exceed  
13 fifteen thousand dollars (\$15,000).  
14 (c) The selling price for one (1) ticket for a pull tab, punchboard, or  
15 tip board game may not exceed ~~one dollar (\$1)~~ **five dollars (\$5)**.

 18 SECTION 20, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE  
 19 JULY 1, 2023]: Sec. 6. (a) ~~Except as provided in subsection (b)~~; A type  
 20 II gambling game **in which tickets are sold for at least one dollar**  
 21 **(\$1) but not more than five dollars (\$5)** must pay out at least  
 22 seventy-five percent (75%) and not more than one hundred percent  
 23 (100%) of the amount wagered.

24 (b) This subsection applies only to a type II gambling game ticket  
 25 that is sold for less than one dollar (\$1). A type II gambling game  
 26 subject to this subsection must comply with the following minimum  
 27 payout percentages:

Purchase Price	Minimum Payout Percentage
\$0.10	60%
\$0.25	65%
Three (3) tickets for one dollar (\$1)	65%
\$0.50	70%

34 (c) A type II gambling game's payout percentage must be stated on  
 35 the ticket or on the accompanying flare.



## COMMITTEE REPORT

Madam President: The Senate Committee on Public Policy, to which was referred Senate Bill No. 172, has had the same under consideration and begs leave to report the same back to the Senate with the recommendation that said bill be AMENDED as follows:

Page 1, after line 15, begin a new paragraph and insert:

"SECTION 2. IC 4-36-5-5, AS AMENDED BY P.L.145-2021, SECTION 18, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2023]: Sec. 5. (a) Except for a raffle game, the total prizes awarded for one (1) type II gambling game may not exceed ten thousand dollars (\$10,000).

(b) A single prize awarded for one (1) winning ticket in a type II pull tab, punchboard, or tip board gambling game may not exceed five hundred ninety-nine dollars (\$599).

(c) A single prize awarded for one (1) winning ticket on a seal card in a type II pull tab gambling game may not exceed one thousand dollars (\$1,000).

(d) A single prize awarded for one (1) winning ticket on a progressive or carryover pull tab game in a type II gambling game may not exceed five thousand dollars (\$5,000).

(e) The selling price for one (1) ticket for a type II gambling game may not exceed ~~one dollar (\$1)~~ **five dollars (\$5)**. Tickets sold for less than one dollar (\$1) must be sold for a price specified in section 6(b) of this chapter.

SECTION 3. IC 4-36-5-6, AS AMENDED BY P.L.108-2009, SECTION 20, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE JULY 1, 2023]: Sec. 6. (a) ~~Except as provided in subsection (b)~~, A type II gambling game **in which tickets are sold for at least one dollar (\$1) but not more than five dollars (\$5)** must pay out at least seventy-five percent (75%) and not more than one hundred percent (100%) of the amount wagered.

(b) This subsection applies only to a type II gambling game ticket that is sold for less than one dollar (\$1). A type II gambling game subject to this subsection must comply with the following minimum payout percentages:

Purchase Price	Minimum Payout Percentage
\$0.10	60%
\$0.25	65%
Three (3) tickets for one dollar (\$1)	65%
\$0.50	70%



(c) A type II gambling game's payout percentage must be stated on the ticket or on the accompanying flare."

Renumber all SECTIONS consecutively.  
and when so amended that said bill do pass.
