## **SENATE BILL No. 172**

DIGEST OF INTRODUCED BILL

Citations Affected: IC 5-2-18.2-7; IC 35-52-5-4.2.

**Synopsis:** Failure to assist in immigration enforcement. Makes it a Class B misdemeanor for: (1) a law enforcement officer to refuse to cooperate with state or federal agencies or officials in the enforcement of immigration laws; and (2) an individual to adopt a policy barring a law enforcement officer from cooperating with state or federal agencies or officials in the enforcement of immigration laws. Establishes certain defenses for the law enforcement officer.

Effective: July 1, 2025.

A BILL FOR AN ACT to amend the Indiana Code concerning criminal law and procedure.

Be it enacted by the General Assembly of the State of Indiana:

governing immigration commits refusal to assist with immigration
enforcement, a Class B misdemeanor.

(c) An individual exercising supervision or control over a law
enforcement officer or agency who adopts a policy or rule that
