

SENATE BILL No. 184

DIGEST OF INTRODUCED BILL

Citations Affected: IC 5-10-8-27; IC 27-8-40; IC 27-13-7-29.

Synopsis: Coverage for clean dietary supplements. Requires a state employee health plan, a policy of accident and sickness insurance, and a health maintenance organization contract to provide coverage for clean dietary supplements that are prescribed to certain individuals by a health care provider.

Effective: July 1, 2025.

A BILL FOR AN ACT to amend the Indiana Code concerning insurance.

Be it enacted by the General Assembly of the State of Indiana:

1 SECTION 1. IC 5-10-8-27 IS ADDED TO THE INDIANA CODE
2 AS A **NEW** SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
3 1, 2025]: **Sec. 27. (a) This section applies to a state employee health
4 plan that is established, entered into, amended, or renewed after
5 June 30, 2025.**

6 **(b) As used in this section, "clean dietary supplement" means:**
7 **(1) a collagen protein;**
8 **(2) a 5-Hydroxytryptophan;**
9 **(3) a pan 10x;**
10 **(4) an iodine;**
11 **(5) a vitamin D; or**
12 **(6) a magnesium;**
13 **dietary supplement.**

14 **(c) As used in this section, "covered individual" means an
15 individual entitled to coverage under a state employee health plan.**

16 **(d) As used in this section, "health care provider" means a
17 person that provides physician services (as defined in**

2 (e) As used in this section, "state employee health plan" means
3 the following:

4 (1) A self-insurance program established under section 7(b) of
5 this chapter.

6 (2) A contract for prepaid health care services entered into
7 under section 7(c) of this chapter.

8 (f) A state employee health plan shall provide coverage for clean
9 dietary supplements that are prescribed to a covered individual by
10 a health care provider.

11 SECTION 2. IC 27-8-40 IS ADDED TO THE INDIANA CODE AS
12 A NEW CHAPTER TO READ AS FOLLOWS [EFFECTIVE JULY
13 1, 2025]:

14 **Chapter 40. Coverage for Clean Dietary Supplements**

15 **Sec. 1. This chapter applies to a policy of accident and sickness
16 insurance that is issued, delivered, amended, or renewed after June
17 30, 2025.**

18 **Sec. 2. As used in this chapter, "clean dietary supplement"
19 means:**

20 (1) a collagen protein;

21 (2) a 5-Hydroxytryptophan;

22 (3) a pan 10x;

23 (4) an iodine;

24 (5) a vitamin D; or

25 (6) a magnesium;

26 dietary supplement.

27 **Sec. 3. As used in this chapter, "health care provider" means a
28 person that provides physician services (as defined in
29 IC 12-15-11-1(a)).**

30 **Sec. 4. As used in this chapter, "insured" means an individual
31 entitled to coverage under a policy of accident and sickness
32 insurance.**

33 **Sec. 5. As used in this chapter, "policy of accident and sickness
34 insurance" has the meaning set forth in IC 27-8-5-1.**

35 **Sec. 6. A policy of accident and sickness insurance shall provide
36 coverage for clean dietary supplements that are prescribed to an
37 insured by a health care provider.**

38 SECTION 3. IC 27-13-7-29 IS ADDED TO THE INDIANA CODE
39 AS A NEW SECTION TO READ AS FOLLOWS [EFFECTIVE JULY
40 1, 2025]: **Sec. 29. (a) This section applies to an individual contract
41 and a group contract that is entered into, delivered, amended, or
42 renewed after June 30, 2025.**
