

SENATE BILL No. 205

DIGEST OF SB 205 (Updated January 12, 2015 12:19 pm - DI 92)

Citations Affected: IC 6-1.1.

Synopsis: Soil productivity factors. Provides that the soil productivity factors used for the March 1, 2011, assessment of agricultural land must be used for the March 1, 2015, assessment date. Specifies that new soil productivity factors shall be used for assessment dates occurring after March 1, 2015.

Effective: January 1, 2015 (retroactive).

Leising

January 6, 2015, read first time and referred to Committee on Agriculture. January 12, 2015, reported favorably — Do Pass; reassigned to Committee on Tax & Fiscal Policy.

SENATE BILL No. 205

A BILL FOR AN ACT to amend the Indiana Code concerning taxation.

Be it enacted by the General Assembly of the State of Indiana:

1	SECTION 1. IC 6-1.1-4-13, AS AMENDED BY P.L.85-2014.
2	SECTION 1, IS AMENDED TO READ AS FOLLOWS [EFFECTIVE
3	JANUARY 1, 2015 (RETROACTIVE)]: Sec. 13. (a) In assessing or
4	reassessing land, the land shall be assessed as agricultural land only
5	when it is devoted to agricultural use.
6	(b) The department of local government finance shall give written
7	notice to each county assessor of:
8	(1) the availability of the United States Department of
9	Agriculture's soil survey data; and
0	(2) the appropriate soil productivity factor for each type or
1	classification of soil shown on the United States Department of
2	Agriculture's soil survey map.
3	All assessing officials and the property tax assessment board of appeals
4	shall use the data in determining the true tax value of agricultural land.
5	However, notwithstanding the availability of new soil productivity
6	factors and the department of local government finance's notice of the

appropriate soil productivity factor for each type or classification of
soil shown on the United States Department of Agriculture's soil survey
map for the March 1, 2012, assessment date, the soil productivity
factors used for the March 1, 2011, assessment date shall be used for
the March 1, 2012, assessment date, the March 1, 2013, assessment
date, and the March 1, 2014, assessment date, and the March 1, 2015,
assessment date. New soil productivity factors shall be used for
assessment dates occurring after March 1, 2014. 2015.

- (c) The department of local government finance shall by rule provide for the method for determining the true tax value of each parcel of agricultural land.
- (d) This section does not apply to land purchased for industrial, commercial, or residential uses.

SECTION 2. An emergency is declared for this act.
